## **Course Description**

Tourism as an industry offers many potential benefits as well as many challenges to community viability. This course will focus on a specific aspect of tourism, natural resource-based tourism, which has a rich global history. We will explore the thesis that thoughtful tourism development and management coupled with ethical natural resource management provides communities an opportunity to lead positive and sustained systemic environmental; social; and economic well-being. This course will provide an opportunity to develop a community of learning by sharing knowledge, insights, and resources as we develop a deeper understanding and appreciation of the intricacies of development and management of tourism, natural resources, and community systems.

#### **Text & Reading Resources**

We will focus on a primary textbook augmented by professional literature, relevant student literature-based presentations, and guest lectures. The primary text that will be used is:

# **Learning Goals**

This course will provide students with the opportunities to examine concepts, issues, and interrelationships between sustainable tourism and natural resource management. Our focus will be on the foundational context of these professional areas through conceptual and practical perspectives. Students will explore sustainable tourism and natural resources management utilizing their particular professional/disciplinary perspectives. This will be accomplished through professional literature research, class discussions, guest lectures, and examination of global examples of significant sustainable tourism and natural resource management endeavors.

# Learning Goals:

Students will develop an understanding of the interrelationships between sustainable tourism and protected area management and the broader system in which they operate.

Students will be able to articulate personal/professional perspectives of key sustainable tourism and protected area management concepts.

Students will be able to describe the significance of sustainable tourism and protected area management practices in relationship to global issues such as climate change, alleviation of poverty, and economic development.

These course outcomes support the Department of Community Sustainability undergraduate program competencies of critical thinking; systems thinking; initiative and practical skills; and ethics. Successful completion of this course provides students with the background needed to appreciate, understand, and contribute to successful leadership in a nature based tourism system. # **Course Structure and Assignments**

Project Teams will be formulated based on professional interests (2 members)

<u>Weekly 2-Page discussion paper</u>. Each student will select an idea or concept of professional interest from the weekly assigned reading and select a <u>journal article</u> that exemplifies or expands upon that idea or concept. The 2-page write-up will include:

- 1. full citation of the journal source (e.g. APA),
- 2. a one-paragraph summary of the article; and
- 3. a discussion of the relationship to the assigned reading. Note: The full literature citation must be sent to the instructor one day before each class session. (10 points each, 100 points total)

<u>Personal definitions/perspectives (September 15)</u>. Select/develop definitions or descriptions (with justifications) of the following terms: leisure, sustainability, system, tourism, community, and management. These are the basic conceptual ingredients of our discussions this semester. (50 points)

Sustainable Tourism Model Identification & Presentation (September 29). Each Team will select a sustainable tourism model that best describes their perspectives on sustainable tourism development and management.

Although this will be a professional team presentation, each student will write his/her own paper. (75 points)

Identification & Presentation of a Sustainable Tourism Natural Resource Management Case (December 1 & 8). Each Team will select, research, and present a sustainable tourism and natural resources management case. Each Team will present their case based on their critical analysis utilizing a sustainable tourism model and relevant professional literature to support their analysis.

Each member of the Team will submit an individually written case study paper by 12 Noon on Friday following the Team's presentation. (150 points)

#### **Extra Credit Opportunities**

**Current trends, issues, and events associated with sustainable management of community services:** Each student may earn up to *30 points* of extra credit during the semester by bringing to class relevant community-based services management items from current newspapers, magazines, professional literature, T.V., radio, or the web. Two points will be earned for each submission (limit is one leisure services management information item per week). Each item must include: **1)** a copy, clipping, and citation of the noteworthy community-based services management information item or a summary of the information and **2)** a one-paragraph discussion of the relevance/significance of the item for sustainable community-based services management.

**Study Abroad Fair Participation:** Each student will earn *20 points* for attending the MSU Study Abroad Fair (**October 15, 2015, 12PM - 6PM, Breslin Center**) and submitting a one-page paper that includes the appropriate evidence of attendance. The paper is to be a thoughtful description of impressions of the event including the identification and discussion of the relevance of at least one Study Abroad Program to his/her personal/professional goals.

**Additional Extra Credit Opportunities:** Throughout the semester extra credit opportunities associated with course topics and current events may be provided.

\* Announced and unannounced quizzes may be given which will affect the final point total for course grading.
