

Minutes for Thursday, June 29, 2023

- 1. Call meeting to order: President Steve Trattles called the meeting to order at 6:37 p.m. All members were in attendance.
- 2. Additions to the Agenda: New Business E Corey Keeslar quote
- Public Comment Chris Yunker and Bill Younts, St. Joseph County Fair Manager and St. Joseph County Director & 4-H Liaison
 - a. Chris would like an inventory of any equipment that is being housed on fair property.
 - b. Chris stated that premium checks will be done by the Fair this year. Lori Templin is their Financial Administrator, Penny Waltke is Treasurer
 - c. Chris asked what specifically is paid for with the \$15,000 contribution from the Fair Board of Directors.
 - d. Cleaning Out Septic Tank and Waltke Pavilion will break ground in Mid July.
 - e. Roofs will be replaced on Barns 16, 17, 22, 24, 26, and 27.
 - f. Friendship Park shrubs are gone and stumps ground out.
 - g. 4-H office at fair leaked again. There is mold. Everything will need to be cleaned out by 4-H. Then professionals will clean the space. Chris Yunker is getting quotes on new gutters, drainage, and roof.
 - h. Campers can leave hoses hooked up if it has backflow preventer is attached.
 - i. Questioned Chris Yunker if Superintendents would have to pay for their fair camping as in the past, the Fair Board did not charge. She will ask about that.
 - j. The August 5th date that was booked and publicized for the Showmanship Clinic will need to be changed to August 12th as Barn #53 was rented to a circus.
 - k. 4-H needs to make a rental policy and present it to the fair. Currently if our equipment is being used and it breaks, we do not have any guidelines for repairs or replacement.
