New MDARD Emergency Order Extends Pesticide Applicator Credentials Until June 2021

A <u>new emergency rule</u> filed on December 30, 2020 by Michigan Department of Agriculture and Rural Development (MDARD) Director Gary McDowell extended pesticide applicator credential expiration dates as part of the state's continued COVID-19 response. Applicators whose credentials expired on December 31, 2019 or December 31, 2020 will have those credentials extended to June 30, 2021. In addition to extending the expiration date, the rule gives applicators six additional months to renew their credential via continuing education courses.

Due to the COVID-19 pandemic, the department is not offering in-person exams. Metro Institute, a private company MDARD has partnered with to offer computer-based exams, is providing limited in-person exams at some of their testing centers. Here are two key portions of the newly-released emergency rule:

- A certified or registered applicator credential with an expiration date of December 31, 2019, is considered valid until June 30, 2021. A qualified certified or registered applicator who renews a credential with an expiration date of December 31, 2019, shall be issued a credential that is valid until December 31, 2022. A certified or registered applicator credential with an expiration date of December 31, 2020, is considered valid until June 30, 2021. A qualified certified or registered applicator who renews a credential with an expiration date of December 31, 2020, shall be issued a credential that is valid until December 31, 2023.
- An applicant who desires to renew his or her credential by seminar shall earn all renewal credits before the expiration of the credential, except that an applicant with a credential that expires on December 31, 2019 or December 31, 2020 who wishes to renew his or her credential by seminar, shall earn all renewal credits before June 30, 2021.

What does this mean in plain English?

First, that if your license expired either at the end of 2019 or 2020, it is being renewed automatically until the end of June of this year. Second, if you would like to renew your license by earning continuing education (a.k.a. RUP) credits, you can now do that until the end of June of this year.

Here is a related note from Bruce MacKellar: "We will be holding educational sessions to provide re-certification for private and commercial applicators that need to gain credits to recertify in specialized categories such as grain fumigation and right of way applications. For more information on these programs as they become available, contact the Van Buren County MSU Extension office at (269) 657-8213 and request to be notified of our

programs via email. For those that would like to take a complete course where you can earn 12 RUP credits in one place, the <u>Pesticide Applicator Training Course</u> is a multiple-hour online class that takes you through the complete core manual at your own pace. The base price for completing the course is \$75/person, with price reductions available for veterans."

FFA Issues Much-Anticipated Drone Rules

The U.S. Department of Transportation's Federal Aviation Administration (FAA) announced last month final rules for Unmanned Aircraft (UA), commonly known as drones. The new rules will require Remote Identification (Remote ID) of drones and allow operators of small drones to fly over people and at night under certain conditions. Remote ID will help mitigate risks associated with expanded drone operations, such as flights over people and at night, and both rules support technological and operational innovation and advancements.

Remote ID (PDF) is a major step toward the full integration of drones into the national airspace system. Remote ID provides identification of drones in flight as well as the location of their control stations, providing crucial information to our national security agencies and law enforcement partners, and other officials charged with ensuring public safety. Part 107 of the federal aviation regulations currently prohibits covered drone operations over people and at night unless the operator obtains a waiver from the FAA. The new FAA regulations jointly provide increased flexibility to conduct certain small UAS without obtaining waiver.

The <u>Remote ID rule</u> (PDF) applies to all operators of drones that require FAA registration. There are three ways to comply with the operational requirements:

- 1. Operate a standard Remote ID drone that broadcasts identification and location information of the drone and control station;
- 2. Operate a drone with a Remote ID broadcast module (may be a separate device attached to the drone), which broadcasts identification, location, and take-off information; or
- 3. Operate a drone without Remote ID but at specific FAA-recognized identification areas.

The <u>Operations Over People and at Night rule</u> (PDF) applies to Part 107 operators. The ability to fly over people and moving vehicles varies depending on the level of risk a small drone operation presents to people on the ground. Operations are permitted based on four categories, which can be found in the <u>executive summary</u> (PDF) accompanying the rule. Additionally, this rule allows for operations at night under certain conditions.

The final rule also replaces the requirement to complete a recurrent test every 24 calendar months with the requirement to complete updated recurrent training that includes operating at night in identified subject areas.

Both rules will become effective 60 days after publication in the Federal Register which is expected this month. The Remote ID rule includes two compliance dates. Drone manufacturers will have 18 months to begin producing drones with Remote ID, with operators having an additional year to start using drones with Remote ID.

MSU Extension Farm Bill Program & Crop Insurance Webinars

For the upcoming 2021 production year, producers once again have the opportunity to select which Farm Bill program will work best for their farms. However, the choice between Price Loss Coverage (PLC) and Agricultural Loss Coverage (ARC) will now only focus on one production year and may be a different decision than the one made for 2019/2020. Crop insurance options like the Supplemental Coverage Option (SCO) and the new Enhanced Coverage Option (ECO) are also important factors in determining which program may be best. MSU Extension is partnering with Michigan Farm Bureau to help guide producers through these considerations and make the best choice for their farms.

Introducing the "2021 Farm Bill Program & Crop Insurance Decisions – What Fits Your Farm?" series. The program will be held via Zoom on January 18, 19, 25, 26 and February 1, 2 at 5-6 p.m. each day. There will be an additional 30 minutes of informal discussion following each session. Registration is free, but you will need to register online for one of the dates to receive the link.

At these informational meetings, producers will:

- Hear highlights from the 2020 decisions and how those decisions played out across the state
- Learn the latest changes regarding ARC and PLC
- Learn about the current and new crop insurance options available
- Work through case examples using the "updated" MSU Extension Farm Bill Calculator to help make better decisions on ARC versus PLC (Each crop and FSA farm number may result in a different choice)
- Discuss specific program details with experts

Michigan Soybean Yield Contest Winners


Last month the Michigan Soybean Association announced the winners of the 2020 Soybean Yield Contest. We had a few winners in the southwest region—congratulations to each of you!



Weather Update


The winter thus far has been much warmer than normal and, for much of the southwest and south central region, drier than normal. Not surprisingly, there is a gradient with precipitation moving away from the Lake. As I mentioned before, the variability in La Niña years makes it nigh impossible to predict weather based on that one phenomenon. With surface water still in the 40's F and only 7% of ice cover for Lake Michigan, lake-effect snow is likely when weather patterns are out of the north/northwest. However, with little precipitation on the horizon for early- to mid-January, we'll need to wait on late-winter and spring precipitation to replenish drier soils heading into the 2021 season.





So far this season, La Niña has brought warmer and drier than normal conditions for most of the Midwest.




Ice coverage on the Great Lakes as of January 4, 2021 (top) and annual ice coverage on Lake Michigan (bottom).




Precipitation percentage of normal for the last 30 days. There is a definite NW-SE gradient with Grand Rapids being the epicenter for above-normal precipitation.
