### 2019 Michigan Corn Hybrids Bulletin Available

The 2019 Michigan Corn Hybrids Compared Extension Bulletin E-431 has been posted on the <u>MSU</u> <u>variety trials website</u>. Individual datasets by zone for grain, silage, and conventional hybrids are also available on the webpage. Feel free to pass this link to others who might be interested in the data.

### USDA Designates 22 Michigan Counties as Primary Natural Disaster Areas

In December, the <u>USDA designated 22 Michigan counties</u> as primary natural disaster areas. Producers who suffered losses due to recent weather events may be eligible for USDA Farm Service Agency (FSA) emergency loans. Losses due to freeze, excessive rain, and excessive rain, flooding, and flash flooding are included for several counties—and contiguous counties—in southwest and south-central Michigan.

These natural disaster designations allow FSA to extend much-needed emergency credit to producers recovering from natural disasters. Emergency loans can be used to meet various recovery needs including the replacement of essential items such as equipment or livestock, reorganization of a farming operation or the refinance of certain debts. ### 4-H Tractor Operator Program Offered in Cass County

MSU Extension and the Cass and St. Joseph County 4-H Programs will be offering the 2020 Tractor Operator Program (TOP) through 4-H Youth Development. Successful completion of the 4-H TOP provides a certificate of training from the U.S. Department of Labor required for operation of a 20 PTO HP or greater, garden or agricultural tractor, by 14 through 19 year old youth employed on property not owned, leased or operated by a parent or legal guardian. Certification is also utilized by youth who exhibit and participate in local contests, parades and festival activities.

The three-week course will be taught on Saturdays, 8:00 a.m. - 4:00 p.m., February 1 - 15, 2020. This schedule includes educational sessions, some driving practice, written and driving tests, and graduation.

We require a minimum of 24 hours of instruction and participants must be 14 years of age by the date of the driving test to be eligible for federal certification. Attendance at all sessions is required for successful completion of the course.

Sessions will be held at the First Baptist Church-Newberg at 13021 Born St., Jones, MI. Cost is \$25 for current 4-H members and \$45 for Non-members. Course fee includes lunch and snacks each day. Due to the generous sponsorship of this program by Midwest Energy and Communications, \$15 will be refunded upon successful completion of the course.

The course will run if the minimum number of participants have registered. Participants must make payment in full (cash or check) at the Cass or St. Joseph County MSU Extension offices and submit all completed paperwork by January 23, 2020 to be registered. Class size is limited to 15 students, so register early! ### **Important USDA-FSA Reminders**

**CRP Sign-up.** USDA opened signup for the Conservation Reserve Program (CRP) on December 9, 2019. The deadline for agricultural producers to sign up for general CRP is February 28, 2020, while signup for continuous CRP is ongoing.


**2019** Acreage Reporting. In order to comply with FSA program eligibility requirements, all producers are encouraged to visit their local FSA office to file an accurate crop certification report by the applicable deadline. Acreage reporting dates vary by crop and by county so please contact your local FSA office for a list of county-specific deadlines.

### **FAA's Remote ID for Drones Proposal**

The Federal Aviation Administration (FAA) has issued the <u>proposed rule</u> for <u>remote identification of</u> <u>drones</u>. With nearly 1.5 million drones and 155,000 remote pilots registered with the FAA, the ability to provide identification and location is essential to keeping drones safely separated from other aircraft operating in our airspace.


We encourage drone enthusiasts, and anyone interested in aviation safety, to read our <u>Notice of</u> <u>Proposed Rulemaking</u> now in the Federal Register and provide feedback during the 60-day comment period.

Equipping drones with remote identification technologies would build on previous steps taken by the FAA and the UAS industry to safely integrate operations, including the <u>small UAS rule</u>, which covers drones weighing less than 55 pounds other than model aircraft, and the <u>Low Altitude Authorization and</u> <u>Notification Capability (LAANC)</u>, which automates the application and approval process for drone operators to obtain airspace authorizations.




Weather Update




Temperature departures from normal for fall (left) and December (right) 2019. September temperatures were up to 7°F above normal, while October temperatures ranged from 4°F below normal to 5°F above normal in the Great Lakes region. November temperatures were as much as 7°F below normal. Autumn temperatures ranged from 4°F below normal to 4°F above normal.




Rainfall totals in the last 30 days—mostly normal to slightly above normal with higher precipitation levels heading toward the center of the state.




The 10-day forecast for Centreville according to wunderground.com.
