MEDIUM ALCOHOL FUEL PLANT INFORMATION

As requested, enclosed are the necessary forms in applying for a permit as a MEDIUM producer of alcohol fuel. Please be sure to provide an Email address, when you submit your paperwork, for contact purposes. This will enable us to notify you when we receive your application and possibly process your paperwork more quickly. The following forms must be submitted to this office:

- 1. TTB F 5110.74, Application and Permit for an Alcohol Fuel Producer Under 26 U.S.C. 5181. You must include all information requested in Instruction 11a-f of the application.
- 2. TTB F 5110.56, Distilled Spirits Bond (TWO ORIGINALS, NO PHOTOCOPIES)
- 3. TTB F 5000.29, Environmental Information
- 4. TTB F 5000.30, Supplemental Information on Water Quality Considerations
- TTB F 5000.9, Personnel Questionnaire, for each officer, director, or stockholder of more than 10 percent in a corporation; individual owner; partner; or member/manager of a limited liability company (SINGLE COPY)
- 6. TTB F 5100.1 Šigning authority, if applicable

SIGNATURE AUTHORIZATION – If someone will be signing the application and/or supporting documents or act on your behalf, you must submit one of the following with your application:

- TTB F 5000.8, Power of Attorney
- TTB F 5100.1, Signing Authority for Corporate Officials. This may be granted by title rather than individual name, or
- Corporate resolution or specific notification in organizational documents granting this authority

If you are filing as a sole owner and someone will sign documents on your behalf, you must file TTB F 5000.8, Power of Attorney.

If you are filing as a corporation, you must also file:

- Copy of Articles of Incorporation
- List of officers, directors, and anyone holding more than 10 percent stock, including addresses and showing the number of shares held
- Copy of the certificate of incorporation executed by an officer of the state in which incorporated
- A statement of the total number of stock shares issued

If you are filing as a limited liability company, you must also file:

- Copy of Articles of Organization
- List of members/managers, including addresses, and their percentage of interest
- Copy of the certificate of organization executed by an officer of the state in which incorporated

If you are filing as a partnership, you must also file:

- Copy of Partnership Agreement
- List of the partners, including addresses, and their percentage of ownership
- Copy of the certificate of partnership where required to be filed by any State, county, or municipality
- If there is a verbal agreement rather than a written partnership agreement, please provide a written statement to that effect signed by all partners. If no single partner has signing authority on behalf of the partnership, all partners must sign each form sent to this office.

If the premises to be used for this operation are eligible for the National Register of Historic Places, you should not begin construction or remodeling until you have contacted the State Historic Preservation Officer (see enclosed information).

A legible photocopy of the Driver's License or official State ID card of the primary contact person who will be interviewed by phone by TTB regarding the application must also be submitted.
