ANNUAL MAPLE SYRUP PROGRAM

Michigan State University Extension (MSU-E) and the Michigan Maple Syrup Association (MMSA) will be co-sponsoring a day-long educational program on **Saturday**, **January 16**, for any interested maple syrup producers.

The highlight of this year's program will be two in-depth presentations focusing on "Determining Your Cost of Production for Maple Syrup" by Bob Battel, MSU Extension and "Marketing of Maple Syrup using Social Media" by Beth Stuever, MSU Extension and Sue Steuver Battel, Stuever Battel Public Relations.

In addition, there will be several Breakout Sessions after lunch that will focus on tubing installation for sap collection; using reverse osmosis technology to concentrate sap; and tips on conducting a sugar house tour for the public. One of the breakout sessions includes a "Beginner's Session" for newer producers as well.

In addition to the educational program, there will be several maple syrup equipment dealers and suppliers who will be exhibiting their equipment as well as a maple syrup judging contest by MMSA.

The program will be held at the Doherty Hotel Conference Center on the I-127 Business Loop in downtown Clare, and will run from 9:30 a.m. – 3:30 p.m.. Registration for the program begins at 8:30 a.m. and costs \$40.00 per adult and \$15.00 per child, age 6-13 (under age 5 free). Registration fees are payable at the door. This fee includes a buffet lunch, refreshments, and program costs.

The meeting will include MSU specialists, local extension educators, wine grape growers, vineyard managers, and winemakers. The meeting will be held from **1:30 - 4:00pm**. We would love your participation as your input is important in determining the direction of our research and extension activities.

The 2010 Northwest Michigan Orchard and Vineyard Show is scheduled for January 19-20 and will be held at the Grand Traverse Resort, Acme, Michigan. Registration begins at 8 a.m. on January 19 and the show will cost \$30 for both days. On Tuesday, there will be concurrent tree fruit and wine grape sessions, and all groups will join together for the Fruit Industry luncheon; the cost for the lunch is \$15. Guest speaker for the luncheon will be Merlin Dumbrille, retired host of Farm and Orchard Time, WTCM-AM, and his topic will be "An Agricultural Outlook."

On Tuesday evening, a wine-tasting and hors d'oeuvre social hour will follow the educational sessions at 5:15. The Cherry Marketing Institute's (CMI) luncheon will be held on Wednesday and is *free* to growers that register with CMI. In addition to the educational sessions on both days, the exhibit hall will be open during the show and will feature vendors of orchard and vineyard equipment and supplies, as well as commodity organizations, agrichemical businesses, and many other exhibitors.

We are excited to host Dr. Bob Bors, Assistant Professor and Head of the Fruit Program at the University of Saskatchewan. Dr. Bors will be sharing his expertise in breeding dwarf tart cherries. He will speak on dwarf cherry production and new harvesting technologies that have potential with smaller trees. In addition, Michigan State University experts and Extension personnel will be on hand to present the results of their latest research on topics regarding tree fruit production: stem-on sweet cherry production, new European and American brown rot strategies, insecticide coverage with different sprayer technologies, cherry fruit fly management, rain fastness in fungicides, borer mating disruption, and many other tree fruit topics. In addition, a grower-panel will speak about their experiences with the Good Agricultural Practices (GAP) audits for 2009. The concurrent wine grapes session on Tuesday will include a panel discussion on how to best manage wine grapes during a challenging season like 2009. We will also get an update on fungicide sensitivity of powdery mildew and Dr. Stuart Grandy, Dept of Crop and Soil Sciences, MSU, will present work on keeping soils healthy to maximize wine grape production.

NW MICHIGAN HORTICULTURAL RESEARCH FOUNDATION ANNUAL MEETING

The 2010 Northwest Michigan Horticultural Research Foundation annual meeting will be held on **Wednesday, January 20th at 9 a.m.** in the Governor's Hall at the Grand Traverse Resort, Acme, MI during the NW Michigan Orchard and Vineyard Show.

The agenda will include the election of directors (three directors, each for a 3-year term) as well as a vote to restate the Articles of Incorporation (see the explanation below).

At this time, the Foundation is still working under the original *Articles of Incorporation* that were adopted in 1978. Because the Articles had not be reviewed since 1989, the board formed a committee earlier this year to review the *Articles of Incorporation* and *By-Laws* in order to bring them into compliance with all state and federal laws as well as the current practices of the board. The committee worked with the Foundation's legal counsel to make the needed revisions. At the June 4th board meeting, a motion was passed to bring recommendations regarding the articles to the membership at the 2010 Annual Meeting during the Orchard and Vineyard Show.

The first step needed to enact the recommended changes is to file a "Restated Articles of Incorporation" with the State of Michigan. The modifications to the Articles will ensure they are consistent with the legal requirements under Michigan and federal law and clarify areas from the earlier version. One additional change suggested by our legal counsel is to change the Foundation to a directorship organization from the current status of a membership organization. This recommendation will neither change the purpose/mission of the Foundation, nor will it change the Foundation's responsibilities to the fruit industry. However, the change will allow the Board to operate the Foundation more effectively for the industry. The following statement is from Rachel Brochert Roe of Smith, Haughey, Rice and Roegge regarding this change:

"It should also be noted that when the Articles of Incorporation were filed in 1978, the only option available to nonprofit organizations was to form as a membership organization. The concept of a directorship-based organization was not introduced until the 1980s. Since that concept was introduced, I would estimate that 90% of all nonprofits are established as directorships because it is seen as a much more efficient way of operating an organization."

The Board members, including the review committee and the Board's Counsel, agree that these changes are in the best interest of the Foundation and the grower community.

APPLICATIONS FOR 2010 ORGANIC FARM REGISTRIES BEING ACCEPTED

Michigan's "Certified Organic Farm Registry" compiles a list of state organic farms and is provided to all commercial firms licensed in agricultural, right-of-way, or aerial pesticide application. The registry information is provided to these firms so they can identify organic farms and take the additional precautions necessary to prevent pesticide drift onto these sensitive sites. The registry is published annually on March 15 and the deadline for submitting an application for the 2010 registry is **March 1, 2010**.

LEARN ABOUT ORGANIC FARM RESEARCH AT ANR WEEK SESSION

Organic growers, agribusiness managers, gardeners, students and others interested in organic agriculture can learn about the topic during the Michigan Organic Food & Farming Reporting Session and Graduate Poster Contest, set for **March 5** as part of Michigan State University's (MSU's) Agriculture and Natural Resources (ANR) Week here.

This event, which will run from 1 to 5 p.m. at the MSU Kellogg Hotel and Conference Center, will feature organic research reports, an organic farmer panel discussion and graduate student poster presentation.

The research reporting sessions will offer topics on organic agriculture production, including fruit, vegetable and field crops, in addition to integrating animals with fruit production and marketing innovations.

Ten presentations will be offered in two concurrent sessions. These sessions will be followed by a panel discussion with several Michigan organic farmers who will share the results of their research and organic production experiences.

Graduate students are invited to submit research posters to compete for cash prizes sponsored by the MSU Environmental Food and Farming Systems program and the Michigan Organic Food and Farming Alliance (MOFFA).

2010 IPM THINK TANK MEETING

Since our last IPM Think Tank in 2008, there has been much research into cover cropping as well as a great deal of interest in orchard floor management. For the 2010 IPM Think Tank, we are fortunate to have Dr. David Granatstein on the program. Dr. Granatstein is the statewide coordinator for the Center for Sustaining Agriculture and Natural Resources at the Tree Fruit Research and Extension Center in Wenatchee, Washington, where he has studied the use of compost as a soil amendment, mulches, cover crops for both nutrient improvement and for beneficial insect habitat, the Swiss sandwich technique, and rodent repellent plants. He has also compared the benefits of growing cover crops in the tree row and those grown in the alley. His big question addresses how growers can improve upon the standard of sod alleys and weed spray strips; this method has served the tree fruit industry well, but he is looking at many aspects of improving this system. We will also host Dr. George Bird and other Michigan State University specialists who will share their insights on cover cropping and soil health. **The meeting will be held at the Northwest Michigan Horticultural Research Station on April 7 from 9-4.** There is a \$25 registration fee that includes lunch.
