A lifelong Fremont resident, Harmon-Ramsey previously co-owned Cart-Right Recycling with her husband, Mark, serving Newaygo County and beyond for more than 15 years. She also serves on the Fremont City Council.

Julie Burrell is the Area Manager of Government & Community Affairs for ITC Holdings, where she partners with local governments, community leaders, and stakeholders to advance infrastructure that supports reliable energy and regional growth. Prior to joining ITC, Julie led economic development efforts for Newaygo County at The Right Place, Inc., where she focused on business growth and rural initiatives across West Michigan. Christopher has successfully led major infrastructure and community development projects, strengthened financial stability through innovative budgeting strategies, and fostered transparent, collaborative organizational cultures. He holds a Bachelor of Arts in Political Science from Oakland University and remains actively involved in numerous professional and civic organizations.

Shelly Kasprzycki

Shelly Kasprzycki is the President and CEO of Fremont Area Community Foundation. Her career includes serving as CEO of Michigan Humanities and other nonprofit organizations. She was recognized as one of Crain's Notable Leaders in Philanthropy in 2025. She serves on the Corewell Health Gerber Hospital Community Board, Newaygo County Economic Development Partnership, and Newaygo County Influential Women in Leadership Committee.

Matt Neiboer

Since 1958, Nieboer Electric has been a staple in the Fremont community. Matt Nieboer is the third generation to lead the family business, which provides commercial, residential, and agricultural electrical services throughout Newaygo County and beyond. Giving back is important to the Nieboer family, and they are consistent volunteers and contributors to local events, school fundraisers, and community needs. He was born and raised in West Michigan and attended Holland Christian High School and Calvin University. With 33 years of work experience in West Michigan across multiple industries, he has called Fremont his home for the past 26 years along with his wife Kristi and their four children. Since 2002, Todd has been an active Board Member and Treasurer for the Fremont Service Committee, a ministry that provides vehicles and vehicle repairs in Newaygo County through the cooperative efforts of local churches, social service agencies, and the Fremont Area Community Foundation.

Dennis Adama

Dennis Adama is an entrepreneur, former elite collegiate athlete, and community advocate. Raised in Newaygo, Michigan, he earned a track scholarship and went on to become a six-time Big Ten Champion and six-time All-American—accomplishments that reflect the discipline and competitive drive he later brought into business. In 1992, Adama founded Compliance Systems, Inc. in Grand Rapids, Michigan, serving as CEO and leading the company's growth into a trusted provider of compliance documentation and technology solutions for financial institutions nationwide. Under his leadership, the company served more than 1,500 financial institutions, helping banks and lenders navigate complex regulatory environments through practical, scalable systems. After retiring in 2020, Adama shifted his focus to giving back. Over the past several years, he has been actively involved in nonprofit work, with a strong emphasis on supporting initiatives in his home county of Newaygo, Michigan. He continues to apply his leadership experience to strengthen local organizations and communities.
