2015 ESP (Michigan Alpha Psi) Chapter Highlights

- In 2015, we had 51 active members and 107 life members.
- ESP chapter officers held four Zoom meetings to conduct official business. This year we created an email group in Outlook for active members and have begun the process of tracking down all ESP life members so that we can maintain a more active outreach to our valued retirees that have opted to continue as life members in the chapter. The National office no longer tracks life members as it had in the past, so our chapter is finding ways to keep connected. - ESP enthusiastically supports the viability of the Extension system as it faces the future. One way we support leadership development to achieve that goal is to send representation to key conferences. In 2015, Deanna East represented our chapter at J-CEP (the Joint Council of Extension Professionals) and Ann Chastain was our ESP chapter representative at the PILD (Public Issues Leadership Development) conference. Our voting delegates for the chapter at the national meeting were Bethany Prykucki and Bonnie Zoia.
- In April, ESP was part of the MSU Extension Retiree Luncheon event. Kathy Forester, Bev Przystas, and Matt Shane interacted with about 85 retirees.
- In May 2015, nine travelers actively participated in an international study trip to Peru. Six were ESP members (Larry Olsen also the study trip coordinator, Georgia Peterson, Marie Ruemenapp, Cheryl Eschbach, Emily Proctor, and Bonnie Zoia), two were trip companions and one was an out-of-state ESP Life member. It was an outstanding international study trip with historic sightseeing, socio-political and cultural exposure, dialogue on social change and community development with volunteers, schools and farms, plus exposure to ancient cultures and ruins. Our Global Relations committee has been busy this year working to enhance future international study trips by proposing a set of guidelines for trip coordinators. A special thank you to committee chair Jan Brinn, and fellow committee members Barb Duvall, Kay Cummings, Jan Hartough, Bethany Prykucki and Ann Chastain.
- Patrick Cudney agreed to serve as our 2015 ESP financial auditor. A non-officer reviews our chapter's financials annually to be sure we are compliant in fiscal management.
- ESP establishes opportunities to support professionalism in Extension. This year, the ESP chapter provided a pre-Fall Extension conference workshop on Adult Learning Styles and Transformative Education by MSU Professor Dr. John Dirkx, Dept. of Educational Administration, at the MSU Credit Union. There were approximately 35 attendees. A special

thank you to the planning committee of Shari Spoelman, Joe Bixler, Ann Chastain and Bethany Prykucki for pursuing the idea of a professional development event and for organizing the event. It was a great success.

• This year the Awards committee was chaired by President Elect Bethany Prykucki, and included two ESP members Julia Darnton and Jennifer Weichel, plus myself. In 2015, we had seven nominations receive awards. In addition to receiving the chapter award, Julie Chapin received the ESP National award for Administrative Leadership.
