Walk Trot Hi-Point (One Showmanship, 5,8,10,13,15)

16&⬇️ Hi-Point (One Showmanship, 6,9,11,14,16,17,19,20)

17&⬆️ Hi-Point (One Showmanship, 7,9,12,14,16,17,19,20)

Daily High Point Rules:

1. Riders age is as of January 1st 2020
2. Points will be counted once fee is payed.
3. 1 horse, 1 rider combination.
4. 1 high point and 1 reserve high point is awarded in each designated division.
5. In the event of a tie breaker, the rider with the most 1st places wins and if still tied the judge may ask a question regarding horse knowledge.

General Rules:

1. Rider age as of January 1, 2020. Horse age as of December 31, 2019.
2. Walk Trot participants may only show in the designated Walk Trot and age appropriate showmanship class.
3. All Stallions must be shown by and adult.
4. ALL riders 19 and under must wear an ASTM/SEI helmet when riding in Gymkhana and English classes.
5. The show committee reserves the right to combine or spilt any classes. 1
6. The show committee reserves the right to require exhibitors or horse's proof of age if there is a dispute.
7. As per Michigan law all horses must have a current year's copy of a negative Coggins test.
