STEER PROJECT REQUIREMENTS:

- Member must be **10 or 11 years** of age by January 1 of the current 4-H Year in order to participate in a Steer Project, with **MINIMUM ONE (1) YEAR previous experience** (feeder calf).
- Member must be **12 years** of age by January 1 of the current 4-H Year in order to participate in a Steer Project, with **NO PREVIOUS experience**.
- In order for your Market Steer Form to be valid, you must also be registered in the 4-H Online system <u>at the time of this forms submission.</u>
- For safety reasons, Steers will be evaluated for handling by the Steer Tagging/Check Committee from January to July, in three Checks, of the current Fair year.

By the July Steer Check, the following criteria must be demonstrated to be met by the Steer Tagging Committee.

- 1. The 4-H Member MUST be able to lead the animal(s) out of its pen and present it to Committee Members.
- 2. The 4-H Member MUST be able to use a show stick with the animal(s) and show progress in this skill at future checks.
- 3. The 4-H Member's animal(s) should be able to be led by anyone.
- 4. Each calf should be equipped with its own show halter, show stick, lead ropes (minimum 2), and a plastic comb.

Calves and Steers will need exercising daily during the Fair. These requirements and the written Steer Check Record are in place to prevent them from being a safety hazard to you or to others.
