RETURNING LEADERS, VOLUNTEERS and MEMBERS—It's time to re-enroll in 4-H!

Leaders, we need you to be enrolled BEFORE we can accept enrollments to your club. Please return to https:// mi.4honline.com to re-enroll, if you have not already done so.



Youth, please re-enroll, and submit payment to the Hart MSUE office ASAP, especially if you are in a market project.

Your 4-H enrollment makes you eligible for 2019/2020 Local, State and National 4-H opportunities such as workshops, Exploration Days, resources, etc. It will also keep you on the mailing list for this newsletter and

Your **PROJECT** application (for market animals or horses) is a separate Oceana County form. These applications get you signed up for a specific project within 4-H. There is **NO** guarantee that by signing up to participate in 4-H that you will get a market spot. There is limited space at the County Fair and we can only take the number allotted. Once you have enrolled there are no refunds made by campus. You can be in 4-H without attending the Fair. 4-H is making your 6 meetings and learning about a certain project area.

Please be timely in submitting your annual enrollment fee, \$20.00 per youth (maximum of **\$60.00** per family) by check payable to **Michigan State University**, cash, credit, or you can request a scholarship from Youth Council. Youth Council is offering scholarships for up to 50% of your fee, if it is not affordable for your family. When you re-enroll you will get a notice that you are in pending status. Once payment is received you will be made active.

You WILL NOT be eligible for market project sign-ups until both the online re-enrollment and payment portions are complete.

We have copies of "how to re-enroll" in the office if needed. We can also email you a copy. Do NOT set up a new family account. You have to re-enroll under the account you already have as a family. If you make a new account it will be deleted and you will have to redo your re-enrollment.

If you have any questions please do not hesitate to ask either Sarah, or Toni, and we can walk you through it.

LARGE and SMALL/JUNIOR MARKET ANNUAL MEETING:

Thursday, October 17, 2019 at 7:00 p.m. Montague High School Auditorium

This year both Large and Small/Junior market annual meetings will be held at the same time. At this meeting checks will be distributed, elections will be held, project rules and changes will be reviewed and applications to participate will be available to pickup. If you are picking up a check from the auction, remember to bring your signed buyers slip. **No slip = no check.** If you can not make the meeting, or forget your buyer's slip, you may pick your check up in the office anytime after the meeting.

HAVE YOUR VOICE HEARD. The committees are looking for youth to run for the Market Livestock Committee. We are taking nominations for YOUTH reps for beef, swine and sheep. Anyone that is interested from any of these project areas needs to let us know so we can add you to the ballot. Market Livestock usually has 6 meetings a year. We are also in need of ADULT VOLUNTEERS (parents, leaders or business reps). The adults are either North or South reps (Baseline road is the dividing road). The **Small Market Animal Committee** is seeking ADULT VOLUNTEERS (parents or leaders) interested in running for the committee. We also need YOUTH NOMINEES from beef, poultry and rabbits /or goats to run for committee spots. There are approximately 4 meetings a year.

Serving on the committees allows you to have your voice heard regarding decisions impacting your animal project and also the market livestock programs as a whole.

This meeting counts as 1 non-club point for market members.

You MUST sign in!

Make sure to attend as the committees will explain any changes for the upcoming 4-H year.

If you can not make it you may pick up your market checks, and market project applications to participate, in the office any time AFTER the meeting. Please note that Large, Small and Junior Market are again all meeting together! This year it is being held near our Southern clubs, at the Montague High School.

PROJECT APPLICATION SIGNUP PROCESS!

Requirements for the automatic re-enrollment program:

- 1. 4-Her must enroll in the same project species as the previous year.
- 2. 4-Her must have achieved a "B" ribbon or better on their most recent market animal notebook entry at the Oceana County Fair
- 3. 4-Her must complete the previous year project by delivering the buyer's photo, obtaining buyer's signature and returning the signed photo form in exchange for their check at the annual meeting, or no later than 4:00 p.m. on November 1st.
- 4. 4-H must have completed their 4-H enrollment form through https://mi.4honline.com and paid the participation fee of \$20 by November 1st.
- 5. 4-Her must be within the Oceana County Fair resident guidelines to be eligible for automatic enrollment.

Additional Guidelines:

- Automatic enrollment option is available if there is no gap in participation year (i.e. must participate in the same animal species project for back-to-back year).
- Automatic enrollment option is not available if changing project areas (i.e. swine to beef, lamb to swine, small market to large market). It can only be used if the 4-Her is staying in the same species area and same markets such as small/jr or large market.
- 4-Her's already in the program (old enough to sell) will be given automatic enrollment priority over Little Buddy members and those who may receive an exception due to not making weight, etc.

Little Buddy Guidelines:

If there is space in the large market program and the little buddy has met four of the five conditions above, they may be automatically enrolled in that large market project. In the event of limited openings, eligible little buddy's may be selected by age (oldest would be allowed in the program first). In order to not wait in line, you need your applications to participate in by November 1st also.

~ After the 4:00 p.m. November 1st deadline for automatic enrollment the office will know how many slots are still available for those needing to wait in line on Saturday, Nov. 9th ~

LEADERS!! If you have not reenrolled in 4-H online (https://mi.4honline.com) and did your background check review that Sarah has sent out, you will not be able to sign applications as you are not an active leader yet. Please don't delay, get this done. If you are not sure of the link please email us and we will send it to you again.

For the Market Programs: Oceana County 4-H Automatic Enrollment Policy for 2019-2020 (if requirements below are met)

Purpose/Policy:	Those who have completed a market project the previous year may sign up in a predetermined window before any new project members.
Scope:	This policy applies to Oceana County 4-H residents only.
Objective:	To implement an improved re-enrollment process for the experienced 4-Her in their specific project area.
Eligibility:	Six conditions must be met to qualify for automatic enrollment in the 2019 – 2020 4-H Large / Small Market Programs.

Requirements for the automatic re-enrollment program:

4-Her must enroll in the same project species as the previous year.

4-Her must have achieved a "B" ribbon or better on their most recent market animal notebook entry at the Oceana County Fair. Animal must have been sold at the Oceana 4-H Livestock Auction(s).

- 4-Her must complete the previous year project by delivering the buyer's photo, obtaining buyer's signature and returning the signed photo form in exchange for their check by November 1, 2019.
- 4-Her must have a completed 4-H Enrollment Form through https://mi.4honline.com and participation fee of \$20 paid by November 1, 2019.

4-Her must be within the Oceana County Fair resident guidelines to be eligible for automatic enrollment.

Additional Guidelines:

Automatic enrollment option is available if there is no gap in participation years (i.e. must participate in the same animal species project for back-to-back years).

Automatic enrollment option is not available If changing project areas (i.e. swine to beef, lamb to swine, small market to large market). It can only be used if the 4-Her is staying in the same animal species project area.

4-Her's already in the project (old enough to sell) will be given automatic enrollment priority over Little Buddy members. Projects not making weight or have an unforeseen issue as to why their animal could not be in the auction; yet all other

project requirements have been met (meetings, notebook, etc.) may consider the below steps:

4-Her to send a letter to their respective committee, requesting an exception, by September 1st at 4:00 p.m.

Once received at the 4-H Office, the letter will be forwarded to the appropriate 4-H leader who will be required to provide either a letter of recommendation or a denial of the request in respect to time spent on the project, etc. The leader's response is due by September 15th.

If the Committee approves the exception, the 4-Her may sign up in the same week as the Little Buddy members. If the Committee does not approve the exception, the Committee will provide sign up direction to the 4-Her.

4-Hers who were granted the exception under Item "C", will have priority over Little Buddy members for automatic enrollment.

Committee will make the final decision by October 1st.

Little Buddy Guidelines (example)

If there is space in the large market swine program and the swine little buddy has met four of the six conditions above (a little buddy does not have a buyer photo/signature requirement nor a sold through auction requirement), they may be automatically enrolled in the Large Market Swine Program. In the event of limited openings, eligible little buddy's may be selected by age (oldest would be allowed in the program first).

Final Authority: The appropriate committee; 4-H Market Livestock Committee, or the Small Market Animal Association Committee, will be the final authority on all matters of concern and can grant/deny exceptions to the above policy/rules.

PROECT RULE CHANGES/CLARIFICATIONS

SMAA MARKET:

Goats: The small market committee has voted to allow the market goat project to do showmanship with either their market animal or a doe (as long as there is space available at the Fair).

LARGE & SMALL MARKET: The committees have voted that those not making weight, or having some other non-controllable issue close to Fair, may submit a letter by September 1st of that year requesting an exception regarding automatic enrollment. This letter will be sent to the leader for either a recommendation or a denial and then to the committee to approve or disapprove.

THE MSUE OFFICE WILL BE CLOSED ON TUES., OCTOBER 29TH AND WED., OCTOBER 30TH AS ALL STAFF WILL BE OUT OF THE COUNTY AT FALL CONFERENCE.

4-H ENROLLMENT

You need to complete your 4-H enrollment <u>PRIOR</u> to Market signups.

This is done online at mi.4honline.com.

The enrollment fee (\$20/ youth, \$60 maximum for families, scholarships available) MUST BE PAID in order to complete your enrollment.

Your enrollment fee is not refundable. You are enrolling in 4-H, there is no guarantee of getting into the market project of your choice.

medals, youth awards, HDC High Point and more.



Michigan Rabbit/Cavy 4-H Scholarship



Award amount: Varies, two to four given annually

Who can apply: Those who will be college freshmen in Fall 2020. Students must have been enrolled in a 4-H rabbit or cavy project for at least three years and have financial need.

Michigan State University 4-H Scholarships

Award amount: **\$2,500** annually for four consecutive years of full-time study at MSU. Six scholarships are given.

Who can apply: 4-H members who are high school seniors must apply to MSU and submit the MSU 4-H Scholarship Application by November 1 of their senior year. Applicants must meet the standard admissions requirements of the university and be accepted to MSU.
