3. I understand that a percentage of the gross sales will be withheld by the SMA committee to cover expenses of the project and auction. All other expenses will be assumed by me.

4. I understand that all enrollments will be accepted on a first come, first serve basis pending available space. If I completed the market geese project last year, and met all of the requirements listed on the **4-H Automatic Enrollment Policy**, I may sign up during the time frame of 10/18/19 through 11/1/19 by 4:00 p.m. at the MSUE Office. **Those who have not participated** in, or completed a market geese project last year, the enrollment time frame for this project is November 9, 2019 from 8:45 a.m. to 9:00 a.m. and will resume during normal business hours (8 a.m.—12 noon & 1:00 p.m.—4:00 p.m.) Tuesday, November 12, 2019 until April 1, 2020, while space is available. Applications will be available October 17, 2019 during the SMAA Annual Meeting and then at the MSU Extension Office until April 1, 2020. There will be a waiting list accepting at least 5 members. Please see attached project rules/requirements for specific details on waiting list system. Space will still be limited to 4 pens.

5. I understand that applications can only be submitted by the 4-H'er, parent/legal guardian or sibling. No other relatives may submit my application. All 4-H Enrollment Forms must be submitted through <https://mi.4honline.com> and fees must be paid before I will be allowed to sign up for a market project and before any paperwork will be accepted.

6. ***I understand that I may drop from the market project without penalty until March 2, 2020.*** If I drop after this time from the market project, I will be disqualified from participating in the Small Market projects the following year. I may appeal to the Committee if there are extenuating circumstances. I also understand that all pictures with breed identified must be on file by 4:00 p.m. July 31, 2020 with the MSU Extension Office (no exceptions... this is your responsibility, not your leaders. ***I understand that no faxes or emails of pictures will be accepted and I will provide a printed color photo.***

7. I must have enrolled in 4-H through [https:// mi.4honline.com](https://mi.4honline.com) and paid the \$20 enrollment fee PRIOR to the project sign up, and ALL application signatures must be completed on this application for acceptance into the project.
