MSU Extension Program Participant Form Sample Script for Staff – Virtual Programming

The collection of demographic data from program participants is an important and mandated aspect of all Michigan State University Extension programming staff, whether those events are held virtually or in person. Below please find a sample script and some best practices tips that you can use as a guide when asking program participant to fill out the demographic data collection forms.

Best Practices Tips:

- Pause your program, somewhere in the middle, to specifically ask participants to fill out the form virtually or in person.
- If your program is being offered virtually, explain the process on how participants should access the form and how to submit it after they have completed it. (You may want to have a separate slide in your show to explain the directions)
- If you are offering the program face to face, ask people to raise their hand if they have a question and go to them individually and answer their question. This will help with other participants adding to the question or "piling on." If you feel that the question that was asked should be shared with the entire group, feel free to interrupt the participants and share the question and answer with all participants.
- If you are offering the program virtually, ask people to place their questions in the chat and converse with them in the chat box.
- Remind participants that if they registered for the program through our Events Management system that they would have been asked to fill out this information. If they don't remember if they fill out this information, they should fill it out now.
- Remind participants, regardless if they are in person or virtual, that answering these questions is **voluntary** and they can check the "choose not to provide" box on any question that they choose not to answer.
- If you are presenting to youth, remind them that they should be **18 or over** to fill out the form on their own. If they are younger than 18, they should get assistance from an adult.

Virtual Program Script:

You can fill the form out completely or choose to respond to different sections at your discretion. If you choose not to provide information in any section, please check the "prefer not to respond" box.
