# Appropriate Use of the MSU Extension Anti-discrimination Statement

The Michigan State University Extension anti-discrimination statement (also known as a "public notification statement" or "indicia") is intended to inform the public that:

- MSU Extension is an affirmative-action/equal-opportunity employer.
- MSU Extension programs are open to all.

This document outlines the rules for appropriate use of the anti-discrimination statement and several other, related statements that must sometimes appear in combination with it. (**Note:** *Some MSU Extension programs, such as SNAP-Ed, EFNEP and 4-H, have additional statements and anti-discrimination disclaimers. The rules for using those program statements are discussed elsewhere.)* The rules covered here apply to all communication, marketing, promotional, and educational materials created by any:

- MSU Extension employee.
- MSU employee or outside vendor who is working under the direction of any MSU Extension employee.

Any version of the anti-discrimination statement and any related statements discussed in this document must be formatted in at least 8-point type and in a readable typeface such as Times New Roman or Arial. Please copy whichever version of the statement is appropriate for your intended use directly from this document into your materials.

#### The Default Statement

The full version of the MSU Extension anti-discrimination statement follows.

This version must appear on:

- Any document that references another party's product or services.
- All brochures, bulletins, promotional materials, flyers, annual reports, conference programs and newsletters.
- All webpages either via a link leading to it on a disclaimer page (such as <a href="https://www.canr.msu.edu/disclaimer">https://www.canr.msu.edu/disclaimer</a>) or in full on each page.

**Note:** An abbreviated version of the statement may be used when space is limited (see the next section). Even if space is tight, however, if commercial products or trade names are mentioned, the full statement is required.

### The Abbreviated Statement

The abbreviated version follows:

MSU is an affirmative-action, equal-opportunity employer. This version may be used in place of the full statement:

- On printed and electronic materials that don't have enough room for the full statement.
- Below the signature lines of email messages sent by MSU Extension staff members from their MSU or MSU Extension accounts.
- On letterhead. (**Note:** Letterhead must also include the following: "Michigan State University, U.S. Department of Agriculture and counties cooperating.")

## Meeting Notices, Registration Materials & Accommodations Statement

When advertising rates are based on the size of the advertisement and the cost is a substantial obstacle, the following options may be used.

### Option 1 (preferred):

The university actively encourages applications and/or nominations of women, persons of color, veterans and persons with disabilities.
