SUPPORTING LOCAL AGRICULTURE



MSU Extension Senior Educator Phil Durst continues his work with beef and dairy farms in the area. Phil and colleagues provided Breeding Soundness Exams for bulls prior to breeding season. These tests, which include assessing the animals' anatomy and mechanics, as well as laboratory assessments, provide assurance that bulls will competently inseminate the herd. Making sure that insemination is done efficiently can help producers shorten the calving season in the spring which then allows producers to plan their year and have efficient processes.



As part of the MSU Extension Animal Agriculture Team, Phil also delivered the Beef Quality Assurance education training for producers - this training delivers information about animal and welfare health at all levels and in all areas, how to ensure quality meat production, and efficiency in production. In addition to all of this, Phil and his colleague, Senior Educator Stan Moore, met with a multigenerational farm business in Oscoda County to discuss marketing strategies for their beef. These processes will help the producer to find the marketplace or market niche for their product to ensure profitability and sustain their operation.
