About the Golf Club

Spring Meadows Country Club is a private club founded in 1957 by a group dedicated to creating a family-focused golf and recreation community. More than fifty years later, the club continues to uphold its founding vision of a welcoming, family-oriented atmosphere for members and their guests.

Linden and the greater Fenton area offer the charm of small-town living with beautiful lakes, parks, and vibrant downtown districts filled with locally owned shops and restaurants. The region provides a strong sense of community and convenient access to Detroit, Ann Arbor, Lansing, and Flint—an inviting place to build both a career and a fulfilling life.

The 18-hole golf course, designed by Packard & Wadsworth, features two putting greens, a short game area, and a driving range. Greens, tees, and fairways are a mix of poa/bentgrass. The pumphouse was fully renovated in 2024 ahead of a new irrigation installation, projected for 2030, with master plan work ongoing in preparation. The chosen candidate will play a key role in work leading up to and during the irrigation renovation.

About the Job

We are seeking an Assistant Golf Course Superintendent who is motivated to advance their career within the turfgrass industry. This position is well suited for candidates at various stages of their professional development, including recent graduates who may have less hands-on experience than some of their peers.

Job Responsibilities

The Assistant Superintendent supports the day-to-day golf course operations at Spring Meadows Country Club, including:

- Taking direction from the Superintendent and Equipment Manager
- Assisting in leading the hourly summer grounds crew
- Daily course setup (mowing, rolling, bunkers, pin/tee locations)
- Executing pesticide and fertilizer applications
- Managing water on all playing surfaces
- Completing irrigation repairs and maintenance
- Participating in construction projects, including rebuilding tees and bunkers, adding drainage, and installing additional irrigation per the master plan
- Winter tree work and equipment maintenance (no weekends in off-season)
- Performing other duties as assigned

Experience Requirements

- Minimum 2 years' experience in golf course or landscape maintenance
- Experience operating heavy equipment preferred
- Strong work ethic and troubleshooting ability
- Ability to work weekends and/or holidays
- Ability to obtain a Michigan pesticide license (3A/5) within 60 days
- Valid Michigan driver's license
- Passion for golf and strong team orientation
