- 8. Reminder that there is a max of 6 rabbits tagged to each 4-H member, can be cross tagged with siblings living in the same household. Make sure names are cross-referenced on each form especially if members have different last names

- 10. Barn Set up
  - a. Weeds pulled and put in manure pit
  - b. Feeders attached to cages
  - c. Put awning around rabbit barn
- 11. Fair Check\*-In Reminders: Friday, September 17, 2021, 4:00 8:00 p.m. <u>All available rabbit</u> <u>leaders should HELP</u>
  - a. EACH rabbit must weigh at least 3 pounds for a minimum of 9 pounds for the market pen
  - b. Carpet Square samples/towels for check in
  - c. Extra scales will be available to double check weights: ONLY 3 Rabbits/member will be accepted at health checks, so make your decision before going to health check line
- 12. Market stock (West End of Barn)
- 13. Breeding stock (East end of Barn)
  - a. Each member needs to know the BREED and age of their breeding stock (I know, you would think)
  - b. ALL RABBITS MUST GO THROUGH HEALTH CHECKS PRIOR TO BEING HOUSED

- 14. Check Stations: List of members for health check
  - a. Tattoo confirmed
  - b. Appropriate Cage & Crock (7-inch crock for market, 5- inch for breeding stock) Cage must have a bottom and rabbits must be separate from their feces and urine.
  - c. Health Check
  - d. Weights
  - e. Evaluation Time
- 15. ALL cage signs must complete and attached to cage(s) before member leaves the barn after weighing-in rabbits

## 16. <u>Members MUST feed, water and clean the pens of their rabbits EVERY morning, beginning</u> <u>Saturday, September 18 - Saturday, September 25, 6:00 - 8:00 a.m. and feed 6:00 8:00</u> <u>p.m.</u> If this is not done, members will receive a yellow tag and must speak to a superintendent. This is meant to be a warning, but if there is a second occurrence, member will earn a red tag which results in their rabbits being removed from the fair grounds.

- 17. Evaluations: Saturday, September 18, 11:00 a.m. 3:00 p.m. Make sure you SIGN UP for a time for market and breeding stock if you have both (at Check-in on Friday night)
- 18. Showmanship age groups:
  - a. 8-10, 11-13, 14-15, 16-19
  - b. Appropriate dress: Black pants, long sleeve white shirt and closed toed shoes (NO nail polish, hats, or jewelry)
- 19. Market & Breeding stock classes- exhibitor may wear dark pants and long sleeve colored dress shirt
- 20. Show Day Sunday, September 19<sup>th</sup> 9:00 a.m.
  - a. Cloverbud check in at 8:00 a.m. EAST end of show arena should be dressed in black pants, white long sleeve shirt
  - b. Show order:
    - i. Meeting (all rabbit exhibitors & leaders), Cloverbuds, 4-H Showmanship, BREAK, Market-Home Bred-Raised, Market-purchased, Breeding Stock
  - c. Tear down and clean up of arena and bleachers
- 21. Weight classes will be posted on the Easels outside the rabbit barn Saturday, September 19 in the Afternoon
- 22. Medication-NONE shall be given without permission of Superintendent and proper paperwork completed. In the event of a rabbit dying, Member must see a Superintendent ASAP.
- 23. Night Barn Monitors (Wednesday-I think)
- 24. Load Out: 10:00 p.m. Saturday, September 25<sup>th</sup> for Market ONLY
