**Re: 2021 Sheep Project Rules and Important Information**

**PLEASE NOTE THAT CHANGES MAY OCCUR DUE TO THE COVID-19 PANDEMIC.**

**2021: All animals must remain on the trailers until told to unload. All members and adults must also remain in their vehicles until told to unload. Masks are required for all persons at weigh-in events. Superintendents have the right to refuse services the day of weigh-in if above is not adhered to.**

**Reminder**

- Michigan Department of Agriculture (MDA) is requiring all lambs that are moved off the farm for sale or exhibition to be ear tagged with a USDA Scrapies ID tag. This is a USDA required program that is designed to identify any animal back to its source if necessary. There is no testing requirement for Scrapies at this time. Anyone purchasing lambs should make sure the seller has tagged them prior to sale. If you raise lambs from your own herd you should contact the MDA at 1-800-292-3939 to get a premises identification number. Once you have the premises number call the USDA at 517/324-5290 to order your free tags and applicator so that you can tag your lambs prior to the initial weigh-in and registration on June 8 or 10, 2021. Do not delay in ordering your tags from the MDA; it may take some time to receive them.
- All Market lambs (including Carcass Contest) must be 100 lbs. or more at check-in for the fair shows.
- **\*\*2021\*\*:** All animas must be checked in by exhibitor or immediate family member unless prior arrangements are made in writing and filed at the MSU Extension office 24 hours in advance of check in times at the fair.
- Evaluations: Interviews and evaluation books are optional for 2021. Times to do the interviews are Saturday, September 18, 11:00 a.m. - 3:00 p.m. at the Sheep Barn.
- **\*\*New for 2021: Skill-A-Thon will be required for ALL Sheep Exhibitors on Sunday, September 19, 2:00-5:00 p.m. at the Henningsen Show Arena.**
- All Sheep will be weighed at the time of unloading. No reweighing of animals.
- Lambs weighing less than the 100lb required minimum weight may show in member age appropriate showmanship class only.
- If a lamb is underweight, the lamb will sell at support price (or may be taken home at the end of fair). If the lamb is a ewe, it may cross over to the breeding stock class if member is dually registered for both breeding stock and market class prior to fair.
- **\*\*New for 2021: Sheep exhibitors may use Natural/dry mulch or shavings for bedding purposes. Breeding Stock Sheep may also use straw.**
- All 4-H Livestock MUST have their Pen Stall Label cards above their pen by Sunday, September 19, 2021, 12:00 noon. Failure to do so may result in a yellow tag. Please refer to the St. Joseph County 4-H Fairbook for yellow/red tag guidelines.
