4-H/CLOVERBUD PROJECT ANIMAL REGISTRATION RULES:

1. 4-H Horse/Pony Project project animals may be owned, borrowed or leased by member. All project animals must be registered in the St. Joseph County MSU Extension office by May 1 of the current project year. All exhibitors may only show animals signed up in exhibitor's name at the St. Joseph County fair. **Members are responsible for supplying the following information regarding each project animal: name, sex, age, breed, and 2" x 3" color full (head to hoof) side body photo of each horse/pony/mini.**
2. Exhibitors may register up to six project animals. Member may only enter one (1) entry in each class number.
3. **Pony Definition:** A pony is any animal 56" and under. A miniature is any animal 38" and under. An official breed card will be accepted for measurement on ponies age 5 and up.
4. **Registered Horse Definition:** "A registered horse for purposes of the St. Joseph County 4-H Horse Project is any horse for which registration papers are on file with the applicable breed association. This includes registered breeding stock horses". **Note:** Any and all horses exhibited at 4-H Horse Council-sponsored shows and in 4-H classes at fair that fit this definition must be shown in "Registered Horse" classes where offered. (Registered horse classes apply to all registered horses other than registered Quarter Horses).
5. Be sure to register any and all potential 4-H project animals at this time in accordance with rules 1 - 4 listed above. **Note:** To the extent possible with horses/ponies available for your use, it's a good idea to register additional project animals (above and beyond those you currently plan to show) as "backup protection" in the event your intended show animal(s) become unavailable to exhibit for whatever reason.
