

# 4-H Market Livestock Sales

## Prospective New Buyer Identification Sheet

**Deadline:** Completed form is due in the St. Joseph County MSU Extension office by Friday, August 19, 2022. Mail or deliver to the MSU Extension Office, 612 E. Main St., Centreville, MI 49032.

**Definition of a "New Buyer"** – A "new" buyer is a person, business or organization that has never before been invited to attend a St. Joseph County 4-H Market Livestock Sale as a prospective buyer. In addition, if a prospective buyer has purchased 4-H market livestock in the past, but it has been more than three (3) years since the last purchase, then that person, business or organization is also considered a "new" buyer (since they will not have a record in the 4-H Market Livestock Buyer computer database).

**Attention:** The names of all prospective new 4-H Market Livestock Sale buyers for a family must be submitted using this form. ***No submitting information to the Extension office by phone or on a separate sheet of paper!*** Only forms with complete prospective buyer information (name, contact person/title (in the case of a business/ organization), street/P.O. box, city, state, zip code and phone number) will be "processed" upon receipt. **Incomplete forms will be returned to the 4-H family listed above for completion, and will delay getting information to your "new" buyer(s).**

"Processing" means the prospective buyer's information will be entered into the 4-H Market Livestock Buyer computer database, thus "pre-registering" the individual/business/organization for participation in the sales. In addition, all prospective buyers (both established and new) will receive, by mail, a ***Buyer Information Letter*** and a one-day car and driver fair admission pass for the day of the sale.

**Special Note:** In the case of a business/organization, the "buyer name" should be the name the prospective buyer would like to have used for publicity purposes when a purchase is made.
