If you are a member of the Large Market Animal project, or are moving up to a large animal, please make every effort to attend. Checks will be distributed, elections will be held, project rules and changes will be reviewed and applications to participate will available to pickup. If you are picking up a check from the auction, remember to bring your signed buyers slip. **No slip = no check.** If you can not make the meeting or forget your buyer's slip, you may pick your check up in the office anytime after the meeting.

We are looking for youth to run for the Market Livestock Committee. We need YOUTH NOMINEES for beef, swine and sheep. Anyone that is interested from any of these project areas needs to let us know so we can add you to the ballot. Market Livestock usually has 6 meetings a year. Serving on the committee allows you to have your voice heard regarding decisions impacting your animal project and also the market livestock program as a whole. #### **SMALL & JUNIOR MARKET ANNUAL MTG.**

Monday, October 24th at 6:30 p.m. Hart Community Center, 407 State Street

(across from the MSUE office in Hart)

We will review fair statistics and rule changes, elect committee members and distribute checks. Remember that you must have your signed buyer's slip in order to pick up your check. No slip = no check. If you can not make the meeting, or forget your buyer's slip, you may pick it up anytime after the meeting.

The Small Market Animal Committee is seeking ADULT VOLUNTEERS (parents or leaders) interested in running for the committee. We also need YOUTH NOMINEES from beef, poultry and rabbits and/or goats to run for committee spots. There are usually 4-6 meetings a year. Serving on the committee is your opportunity to have your voice heard when decisions are made about your project, the auction, etc. If you are interested in being added to the ballot please call us at 873-2129 or email vanberg2@anr.msu.edu.

This meeting counts as 1 non-club point for small/junior market members (it does not count for large market). If you are moving up to Large Market this year, you will want to make sure to attend their meeting as well.

#### STEER WEIGH-IN & TAG RECORDING DATE

The steer weigh-in takes place in the Beef Building at the Oceana County Fairgrounds. It will be held on *Sat., Dec. 3rd* from 8:00-10:00 a.m. Your steer will be weighed to get your starting weight, tag number scanned & picture taken. If you personally can not attend, you must inform the office of the name of your sibling or parent bringing the animal in your absence. This is worth 1 non-club point for steer and feeder calf members.



#### LARGE MARKET PROJECT RULE CHANGES & CLARIFICATIONS

Following are the project rules changes voted on by the Market Livestock Committee for the 2016/2017 4-H year.

#### **Project changes and/or clarifications**

#### 1. #8 in the lamb project, regarding ear tag requirements, will be changed to:

All 4-H Market Livestock lamb project animals will be required to have an Oceana County 4-H ear tag, and a MDA required Scrapies tag, placed in their animal's ear. The 4-H tag will be provided to the leaders from the Extension Office. For those members registering two animals, you will be required to get your second tag from the Extension Office prior to the June 1st deadline. All lambs are required to have a Scrapies tag in their ear which should have been provided at the time you purchased your lamb. It is preferred to have a Scrapie's tag in one ear and the 4-H tag in the other. All ear tags, breeds and pictures must be turned into the Extension Office by Thursday, June 1, 2017. NO EXCEPTIONS!

#### 2. #13 in the lamb project will be changed to read:

No rams will be allowed in the market project. Wether and ewe lambs with docked tails are eligible for 4-H market classes. A wether is a completely castrated male. Animals with testicles, portions of testicles, or yearling teeth will be disqualified from the 4-H market livestock lamb program. Short scrotum, crypotorchid, or ram lambs are not eligible as 4-H market lambs.

#### 3. # 12 Swine project will be changed to read:

Barrow and gilt market hogs are eligible for 4-H market classes. A Barrow is a completely castrated male. Animals with evidence of staginess, testicles, incomplete castration, or with late castration will be disqualified from the 4-H market livestock lamb program. No boars will be allowed in the 4-H Market Project.

#### 4. Regarding replacement animals for sheep & swine the rules will have the wording added:

"All pictures, ear tags and breeds for replacement animal must be on file at the MSU Extension Office no later than August 1, 2017. Failure to do so will results in disqualification from the Market project. Those raising two animals, you may elect to have the "backup" animal as your replacement animals and would need to notify the MSU Extension Office, in writing, of this decision by August 1, 2017.

#### 5. Steer & Lambs.

If an RFID , or Scrapies tag, falls out you need to contact the MSU Extension Office with the new number, no later than two weeks prior to Fair.

#### 6. Non-Club/Club Points:

#12 the words "if held" will be added

#17 will be changed to read: Volunteer to **work** at Grace Adventures Ride For The Ranch April 22, 2017 Added at #29—Attend an out-of-area judging event, coordinated by your leader, to learn more about your market project.

Because of this numbers 29-33 will be renumbered as 30-34.

## MARKET LIVESTOCK PROJECT SIGNUP

Market Livestock Animal Signups will be held <u>Saturday</u>, <u>November 12</u>, <u>2016</u>. You must have your applications to participate filled out with <u>ALL</u> signatures. Applications will not be accepted if missing any signatures.

If you can not make it, you may have a parent, sibling or grandparent submit your forms. If you fax or mail your application, it will be accepted in the order which received beginning Monday, the 14th.

#### The order of sign ups this year will be:

**SWINE:** 8:00-8:30 A.M. (including Little Buddy)

LAMB: 8:30-9:00 A.M. (including Little Buddy)

BEEF: 9:00-9:30 A.M. (including Little Buddy)

(must be 4-H age 10 or older to participate in the Steer or Little Buddy

Steer program)

As always, project enrollments are first come, first served. There are limited stalls/pens at the Fair.

(60 swine, 36 lambs, 48 steer)

#### **4-H ENROLLMENT**

You need to complete your 4-H enrollment PRIOR to Market signups.

This is done online at mi.4honline.com.

The enrollment fee (\$10/ youth, \$30 maximum for families, scholarships available) MUST BE PAID in order to complete your enrollment.

## **NEW MICHIGAN 4-H CURRICULUM**

Youth Business Guide to Success: Make the Most of Your 4-H Market Animal Project

What does it cost to raise a market animal? How can raising a market animal teach positive financial management? What does learning how to present and market have to do with an animal project?

Most young people in 4-H market animal projects are focused on basic animal science, care and management. But market animal projects also have the potential to teach youth valuable life skills.

Through this curriculum, youth will gain knowledge about marketing and advertising their products. Participants will also explore and practice production, management and distribution skills. In addition, it provides a venue to explore what it takes to be successful in business and view the world of animal science and agribusiness as a viable career option.

<u>Curriculum units</u> include goal setting, record keeping, budgeting, communication (verbal and nonverbal) and marketing. These lessons help to foster important life skills such as:

- Responsibility
- Goal setting
- Planning and organizing
- Record-keeping
- Budgeting and financial management
- Problem Solving
- Decision Making
- Marketable Skills
- Teamwork
- Communication (written and verbal)

## **SMAA/JUNIOR MARKET SIGNUPS**

The Small Market and Junior Market Project Registration signup will be held on **Saturday, November 12, 2016** following Large Market beginning at 9:30 a.m. and ending at 10:30 a.m. You must have your applications to participate filled out with **ALL** signatures. Applications will not be accepted if missing any signatures.

A 4-H member may sign up for one animal at this time. If you can not attend sign-ups, a parent, sibling or grandparent may submit your paperwork for you. A 4-Her will have until March 1st to drop without penalty. Beginning March 2nd, members may sign up for a second animal if they wish, pending available space. If you drop out after March 1st, you will NOT be eligible to sell in the Small Market or Junior Markets the following year. You may request a meeting with the SMAA committee if there are extenuating circumstances.

Project Enrollments are first come, first served.

There are limited stalls/pens at the Fair.

The following are the combined project limits for SMAA and Junior Markets.

Chickens – 10 Turkeys - 6 Feeder Calf/Young Beef \* –18

\* you must be at least 4-H age 7 to bring

your own feeder calf

Rabbits- 4 Goats- 6 Ducks- 4 Geese- 4

#### **4-H ENROLLMENT**

You need to complete your 4-H enrollment PRIOR to Market signups.

This is done online at mi.4honline.com.

The enrollment fee (\$10/ youth, \$30 maximum for families, scholarships available) MUST BE PAID in order to complete your enrollment.

Your enrollment fee is not refundable. *You are enrolling in 4-H,* there is no guarantee of getting into the market project of your choice.

#### **SMAA/JR.MARKET PROECT RULE CHANGES/CLARIFICATIONS**

#5 on page 2 of the rules will read:

"No sick animals. Per MDARD Fair & Exhibitions Requirements: livestock with clinical signs of infectious, contagious, or toxicological disease shall be removed from the fair, exhibition, exposition, or show or by permission of the Director, shall be isolated on the premises."

Goats: Will now read

"Must be a wether or doe under one year."

"Must be castrated (healed), and de-horned"

"Must have a 4-H ear tag & Scrapies tag" (note that tattoo has been removed and replaced with a green 4-H tag)

"Weight requirement: 50-100 pounds"



## **4-H SENIORS!**

Michigan Rabbit/Cavy 4-H Scholarship



Award amount: Varies, two to four given annually

Who can apply: Those who will be college freshmen in Fall 2016. Students must have been enrolled in a 4-H rabbit or cavy project for at least three years and have financial need.

#### Michigan State University 4-H Scholarships

Award amount: \$2,500 annually for four consecutive years of full-time study at MSU. Six scholarships are given.

Who can apply: 4-H members who are high school seniors must apply to MSU and submit the MSU 4-H Scholarship Application by November 1 of their senior year. Applicants must meet the standard admissions requirements of the university and be accepted to MSU.

## 4-H Capitol Experience—March 2017

4-H Capitol Experience is an annual 4-day conference that focuses on civic engagement and public policy. Up to 100 teens from around the state converge on Lansing, Michigan to experience state government in action and learn how they can influence policy issues. Participants interact with legislators, state agency staff, lobbyists and other resource people to learn how policy is made. Attendees will:

- Understand the responsibilities of a citizen
- Explore different aspects of a policy issue that may affect individuals and communities
- Explore various careers in public policy
- Attend bill writing session
- Have an in-depth meeting with someone in (or involved with) state government.

Simulations and activities are incorporated to reinforce and apply what is learned about government. Teens leave the conference with the charge to share what they have learned and get involved with other leaders. There are scholarship opportunities available for 4-H Capitol Experience to help pay to attend.

## STATE YOUTH LEADERSHIP COUNCIL

4-H Youth ages 15-19 by January 1, 2017, apply now to serve on the Michigan 4-H State Youth Leadership Council. This is a statewide leadership opportunity that allows youth to connect with 4-H'ers across Michigan and have a voice in Michigan 4-H programs and events. Apply by November 1 online at <a href="https://www.surveymonkey.com/r/SYLC2016">https://www.surveymonkey.com/r/SYLC2016</a>

The Michigan 4-H State Youth Leadership Council is a statewide leadership opportunity for youth ages 15-19. Youth are selected for the council by application and interview with a state committee of MSUE staff. Council members are representatives of the Michigan 4-H Program promoting 4-H at various events; planning, conducting and evaluating national, state, regional, county leadership programs and serving as role models to other youth. Council terms are two years.

Qualifications: Any 4-H participant, age 15-19 by January 1, 2016 can apply for a council position. The 4-H'er must meet the age requirements listed above, must be currently enrolled in a 4-H program, in good standing in their local 4-H club or unit, and have completed the previous year of 4-H work (e.g. 4-H involvement for at least 2 years). Applicants should have an interest in leadership and able to commit time to the completion of SLYC activities. Candidates should be selected by a state committee on the following basis: 40% 4-H experience; 50% personal interview; 10% recommendation by MSU Extension Staff and volunteers.

**Meetings:** The Council meets monthly through Zoom online video conferencing and holds at least two in-person meetings in conjunction with other state 4-H events: 4-H Teen Leadership and Global Citizenship Spectacular (Kettunen Center, January) and 4-H Exploration Days (MSU campus, June).

**SYLC activities include:** promoting 4-H through state and local activities, providing youth voice on 4-H program and curriculum development, training in public speaking, advocacy, and leadership skills. Optional opportunity to represent Michigan in attendance at National 4-H Conference, Washington DC (April 2016 or 2017).

Why would youth be interested in SYLC? SYLC members receive training on public speaking, advocacy, communication and leadership skills. SYLC is Michigan's highest youth leadership opportunity and is a goal that older youth can aspire toward. SYLC members get to broaden their network and expand their knowledge of 4-H programs beyond their counties.

**There is no cost to apply.** Some scholarships may be available to off-set travel expenses to attend face to face meetings and events.

**How to apply**: Interested youth should complete electronic survey which will serve as their application. Applicants must also select two adults, one being their 4-H Program Coordinator, to complete a reference. It will be the applicant's responsibility to distribute reference form information to their selected individuals. References will also be submitted electronically, with links being provided at the conclusion of this survey.
