4-H NEWSLETTER

RETURNING LEADERS, VOLUNTEERS and <u>MEMBERS—It's time to re-enroll in 4-H!</u>

Leaders, we need you to be enrolled BEFORE we can accept enrollments to your club. Please return to https://mi.4honline.com to re-enroll, if you have not already done so.

Youth, please re-enroll, and submit payment to the Hart MSUE office ASAP, especially if you are in a market project. Your 4-H enrollment makes you eligible for 2017/2018 Local, State and National 4-H opportunities such as workshops, Exploration Days, resources, etc. It will also keep you on the mailing list for this newsletter and e-mails with program updates.



Your **PROJECT** application (for market animals or horses) is a separate Oceana County form. These applications get you signed up for a specific project within 4-H. There is NO guarantee that by signing up to participate in 4-H that you will get a market spot. There is limited space at the County Fair and we can only take the number allotted. Once you have enrolled there are no refunds made by campus. You can be in 4-H without attending the Fair. 4-H is making your 6 meetings and learning about a certain project area.

Please be timely in submitting your annual enrollment fee, *\$20.00* per youth (maximum of *\$60.00* per family) payable to *Michigan State University*, cash or you can request a scholarship from Youth Council. Youth Council is offering scholarships for up to 50% of your fee, if it is not affordable for your family. When you re-enroll you will get a notice that you are in pending status. Once payment is received you will be made active.

You WILL NOT be eligible for market project sign-ups until both the online re-enrollment and payment portions are complete.

We have copies of "how to re-enroll" in the office if needed. We can also email you a copy. **Do NOT set up a new family account.** You have to re-enroll under the account you already have as a family. If you make a new account it will be deleted and you will have to redo your re-enrollment.

If you have any questions please do not hesitate to ask either Sam, or Toni, and we can walk you through it.

LARGE and SMALL/JUNIOR MARKET ANNUAL MEETING:

Monday, October 16, 2017 at 7:00 p.m. Shelby Cafetorium at Shelby Middle School

This year both Large and Small/Junior market annual meetings will be held at the same time. At this meeting checks will be distributed, elections will be held, project rules and changes will be reviewed and applications to participate will be available to pickup. If you are picking up a check from the auction, remember to bring your signed buyers slip. No slip = no check. If you can not make the meeting or forget your buyer's slip, you may pick your check up in the office anytime after the meeting.

HAVE YOUR VOICE HEARD. The committees are looking for youth to run for the Market Livestock Committee. We need YOUTH NOMINEES for beef, swine and sheep. Anyone that is interested from any of these project areas needs to let us know so we can add you to the ballot. Market Livestock usually has 6 meetings a year. We are also in need of ADULT VOLUNTEERS (parents, leaders or business reps). *If you are interested please call us at 873-2129 or email vanberg2@anr.msu.edu*

The Small Market Animal Committee is seeking ADULT VOLUNTEERS (parents or leaders) interested in running for the committee. We also need YOUTH NOMINEES from beef, poultry and rabbits /or goats to run for committee spots. There are usually 4 meetings a year.

Serving on the committees allows you to have your voice heard regarding decisions impacting your animal project and also the market livestock programs as a whole.

This meeting counts as 1 non-club point for market members. You MUST sign in! Please note that Large, Small and Junior Market are all meeting together!

LARGE MARKET PROJECT RULE CHANGES & CLARIFICATIONS

Following are the project rules changes voted on by the Market Livestock Committee for the 2017/2018 4-H year.

Project changes and/or clarifications

- 1. There will be a waiting list for all projects. There will be at least 5 waiting list spots for each Market Livestock animal project. If you are placed on the waiting list and are notified of an opening you have 2 weeks to get your application submitted from the notification date. If you are notified prior to the normal project picture, ear tag and breed deadline (Steers –Dec 1st, Hogs –May 10th, Lambs—June 1st) you will be expected to submit your picture, ear tag and breed by the appropriate deadline. If you are notified after these deadlines, you will have 2 weeks to submit your picture, ear tag and breed. The deadline to fill open spots from the waiting list is July 2nd. After July 2nd there will be no filling of open spots.
- On sign-up day, November 11th the <u>4-H member, a sibling, or their parents/legal guardian</u> are the <u>ONLY</u> ones who may be in line and turn in their paperwork for them. If it is discovered that you are not following this rule you will be directed to go to the back of the line.

THIS SYSTEM WILL BE CHANGING NEXT YEAR!

All committees are working together to try to improve the way signups are held. Please be present in order to have any questions or concerns addressed.

STEER WEIGH-IN & TAG RECORDING DATE

The steer weigh-in takes place in the Beef Building at the Oceana County Fairgrounds. It will be held on Sat., **Dec. 2nd** from 8:00-10:00 a.m. Your steer will be weighed to get your starting weight, tag number scanned & picture taken. If you personally can not attend, you must inform the office of the name of your sibling or parent bringing the animal in your absence. This is worth 1 non-club point for steer and feeder calf members who are present.

If you are the waiting list for a steer you will want to bring your steer to be weighed to remain on the list.



MARKET LIVESTOCK PROJECT SIGNUP

Market Livestock Animal Signups will be held <u>Saturday, November 11, 2017</u>. You must have your applications to participate filled out with ALL signatures. Applications will not be accepted if missing any signatures. You must also have already enrolled online and paid your fee (or requested scholarship assistance)

If you can not make it, you may <u>have a PARENT/LEGAL GUARDIAN OR</u> <u>SIBLING submit</u> your forms. <u>There is NO holding of spaces or no other</u> <u>relatives that can hold a spot.</u> If you fax or mail your application, it will be accepted in the order which received beginning Monday, the 13th.

The order of sign ups this year will be:

BEEF: 8:30-9:00 A.M. (including Little Buddy)

(must be 4-H age 10 or older to participate in the Steer or Little Buddy Steer program)

SWINE: 9:00-9:30 A.M. (including Little Buddy)

LAMB 9:30-10:00 A.M. (including Little Buddy) (must be 4-H age 10 or older to participate in the Steer or LB Steer program)

As always, project enrollments are first come, first served. There are limited stalls/pens at the Fair (60 swine, 36 lambs, 48 steer)

4-H ENROLLMENT

You need to complete your 4-H enrollment <u>PRIOR</u> to Market signups.

This is done online at mi.4honline.com.

The enrollment fee (\$20/youth, \$60 maximum for families, scholarships available) MUST BE PAID in order to complete your enrollment.

Your enrollment fee is not refundable. *You are enrolling in 4-H,* there is no guarantee of getting into the market project of your choice.

Youth Business Guide to Success: Make the Most of Your 4-H <u>Market Animal Project</u>

ONE OF THE MANY BOOK/DVDS/CDS THAT MAY BE CHECKED OUT OF OUR 4-H LIBRARY!

What does it cost to raise a market animal? How can raising a market animal teach positive financial management? What does learning how to present and market have to do with an animal project?

Most young people in 4-H market animal projects are focused on basic animal science, care and management. But market animal projects also have the potential to teach youth valuable life skills.

Through this curriculum, youth will gain knowledge about marketing & advertising their products.

Participants will also explore & practice production, management & distribution skills. In addition, it provides a venue to explore what it takes to be successful in business & view the world of animal science & agribusiness as a viable career option.

SMAA/JUNIOR MARKET SIGNUPS

The Small Market and Junior Market Project Registration signup will be held on **Saturday, November 11, 2017. This year Small/Junior will be first and will run from 8:00 a.m.– 8:30 a.m.** You must have your application to participate filled out with **ALL** signatures. Applications will not be accepted if missing any signatures. You must have signed up in 4-H online and paid your fee, or requested scholarship assistance, prior to this day.

A 4-H member may sign up for one animal at this time. If you can not attend sign -ups, *a <u>parent/legal guardian or sibling</u>* may wait in line and submit your paperwork for you. There is <u>NO holding of spaces or no other relatives</u> <u>that can hold a spot.</u> If you do this and it is found out you will be asked to go to the back of the line. A 4-Her will have until March 1st to drop without penalty. Beginning March 2nd, members may sign up for a second animal if they wish, pending available space. If you drop out after March 1st, you will NOT be eligible to sell in the Small Market or Junior Markets the following year. You may request a meeting with the SMAA committee if there are extenuating circumstances.

Project Enrollments are first come, first served. There will be a waiting list. There are limited stalls/pens at the Fair.

The following are the combined project limits for SMAA and Junior Markets.

Chickens– 10	Turkeys- 6	Feeder Calf/Young Beef * –18

4-H ENROLLMENT

You need to complete your 4-H enrollment <u>PRIOR</u> to Market signups.

This is done online at mi.4honline.com.

The enrollment fee (\$20/youth, \$60 maximum for families, scholarship help available) MUST BE PAID in order to complete your enrollment.

Your enrollment fee is not refundable. You are enrolling in 4-H, there is no guarantee of getting into the market project of your choice.

SMAA/JR.MARKET PROECT RULE CHANGES/CLARIFICATIONS

1. Feeder Calf: Will now read: No heifers allowed.

Ear tag <u>MUST be in the calf's ear</u> when turning pictures in.

2. Goats: Market limit of 8

All market animals (with the exception of poultry and rabbits, where the meat can not be handled) the 4-Her is required to show their market project animal. There will be market showmanship classes added to the Fair book.

- 3. There will be a waiting list for all projects. There will be at least 5 waiting list spots for each Market animal project. If you are placed on the waiting list and are notified of an opening you have 2 weeks to get your application submitted from the notification date. Feeder calf members, if you are notified prior to the normal project picture, ear tag and breed deadline of June 1st, you will be expected to submit your picture, ear tag and breed by the appropriate deadline. If you are notified after this deadline you will have 2 weeks to submit your picture, ear tag and breed. All other SMAA/JR Mkt project pictures, tags, breed deadline is August 1st. The deadline to fill open spots from the waiting list is July 2nd. After July 2nd there will be no filling of open spots.
- 4. On sign up day the only ones allowed in line to turn in YOUR application to participate in the Market project are <u>YOU, A SIBLING OR A PARENT/LEGAL GUARDIAN</u>. This rule has <u>changed so take note of it!</u>

Michigan Rabbit/Cavy 4-H Scholarship



Award amount: Varies, two to four given annually

Who can apply: Those who will be college freshmen in Fall 2017. Students must have been enrolled in a 4-H rabbit or cavy project for at least three years and have financial need.

Michigan State University 4-H Scholarships

Award amount: **\$2,500** annually for four consecutive years of full-time study at MSU. Six scholarships are given.

Who can apply: 4-H members who are high school seniors must apply to MSU and submit the MSU 4-H Scholarship Application by November 1 of their senior year. Applicants must meet the standard admissions requirements of the university and be accepted to MSU.
