FAIRBOOK INFORMATION

Sheep members will be limited to two entries in each individual class. All animals showing in breeding classes must be purebred. All pens must be cleaned by 10:00 a.m. on Sunday after fair. Animals are to be owned by exhibitor by May 15 prior to fair. All market and breed lambs must have a USDA scrapie tag before coming to the fair. Members must have all market lambs that will be going to the Kalamazoo County Fair tagged with Kalamazoo County I.D. by the superintendents. Weigh in and tagging is mandatory and will be held on the first Saturday of June in the arena at the Kalamazoo County Fairgrounds. Please check the MSU Extension Kalamazoo County 4-H Newsletter for specific times.

Market Lambs:

Market lambs can be brought in on Saturday or Sunday and must be clean and dry for weigh-in. A specific time frame will be set up for Saturday drop offs. All breeds will compete. They may be grade, purebred or crossbred. All exhibitors are eligible to show 4 lambs if they have participated in the project for at least 1 year. All other exhibitors may show 2 lambs. Unethical treatment of lambs will result in dismissal from the Kalamazoo County Fairgrounds. Animals weighing less than 80# or not considered finished and will be placed in a "C" grouping and are not eligible to sell in the Livestock Sale. Sale weight will be established on Sunday. All animals will be released Sunday after fair.

Showmanship:

All 4-H sheep (both breeding and market) are expected to compete in showmanship.

Market Pen:

Bred and owned by member

Wool:

Exhibitors may exhibit one fleece per class and do not need to exhibit an animal to enter. All wool must be identified with sex and breed on it. Both purebred and commercial wool will be judged together. Only the Champion & Reserve Champion fleece will sell in the sale, with proceeds to be split between fleece and rug producers. Judging takes place during still project exhibit judging on the Saturday before the fair.

Sheep Science:

An educational exhibit is mandatory for members of the Sheep project. This exhibit may be a notebook, poster or a management exhibit.
