- 1. Call meeting to order: 6:35pm. HC Vice President Pam Cook called meeting to order.

  - \* Showbills: Pleasure showbill not available at this time. There is some classes to add.
  - \* Driving would like to propose to hire a 2nd judge for driving and donate \$50 toward the judge.

- \* Reining workout dates need to be schedule for work.
- \* Competitive trail workouts are scheduled. August 7th is the final; it will be held at Camp Eberhart.
- \* Driving approval for moving the ridden dressage to Saturday, September 10. Bobbi Jo motioned Hannah Stauffer second. Motion passed.
- \* Clinic Update: Most spots are filled. T-shirts for attendees are in. Potluck items are finalized.
- \* Judges Committee: Judges hired. Sportsmanship/costume Class judges not yet hired.
- \* All dates for workouts should be to Tonya.
- \* Points Committee: Karen reminded the Horse Council that she is no longer willing to head the points committee and a new committee will need to be formed. Tabled for next meeting.
- \* Amendments to rules and regulations:
  - Motion to Amend by Norma that Prairie Ponies in hand points from driving fundraiser will be included in the Prairie Ponies award. Seconded by Andrea Littlefield. Motion carried.
  - Connie in general rules motioned to amend that Flying lead Changes takes Precedence over Simple lead changes. ADD: Lead changes must follow pattern as specified in state 4-H rule book to be considered. Seconded by Karin Fleetwood. Motion carried.
  - Motion to amend : others ARE able to handle horses on showday by Shirel Hart, second by Tatianna Geruszka, Motion carried.
  - Motion to amend Cloverbud and walk trot kids may share a 4-H horse (added in 2014 and voted and passed however was not put in the rule book)
  - Voting by ballot on all rules and regulations proposed changes. Passed unanimously.
