
What is SARE?



Farmer Rancher Grant Program

- Grants directly fund farmers and ranchers to explore new production methods or marketing approaches for their farm
- Up to \$7,500 for individual farm, \$15,000 for teams of two, and \$22,500 for groups of 3 or more
- Encouraged to link with university or non-profit partners
- 40 projects funded per year
- Coordinated by Joan Benjamin




Farmer Rancher Grants Funded 1988-2017






Youth Educator Grants Funded 2008-2017

General grant information

 Contrary to popular belief, most, if not all, funders <u>do not</u> give you money to spend on whatever you want or need



Extension

- Grant programs have specific objectives for distributing money
 - Government funds often dictated by law
 - Private funds by mission statements or by-laws
- Grant administrators are bound by these constraints and can't change it for you
- Make sure what YOU WANT MONEY FOR is something THEY GIVE MONEY FOR!

Farmer/Rancher Grants are for innovative sustainable agriculture research, demonstration, and education projects; they are NOT for everyday farming expenses, other than those directly related to the grant project. For example, purchasing fencing or livestock to expand your herd would not be allowed. Fencing or livestock needed as part of a research project to explore how different cover crops work in rotational grazing would be allowed, but only for the land and animals involved in the research.

- Applicants must identify specific problems and potential solutions to those problems.
- Maximum duration for grant projects is 23 months.
- Projects that involve whole farm systems and/or a youth component are encouraged.
- Livestock projects need to comply with reasonable animal care requirements to insure that animals are properly cared for. See the Livestock Care form on pages 23 - 25.

General grant information

 Not everyone qualifies for every grant program



- Grant programs have targeted audiences that can meet their objectives
- Some grant programs only fund in certain geographic or demographic areas
- Make sure YOU QUALIFY TO RECEIVE THE MONEY you are applying for!



ELIGIBLE COUNTIES MAP:

- Projects in the following counties are eligible rural (60,000 population or less), or Micropolitan statistical areas:
- Note: Per the Rural Development Fund Act criteria, preference must be given to projects in the region in which revenues are generated and include the following counties: Marquette; Alger; Delta; Menominee; Dickinson; Iron; and Baraga.
- Applicants must be located in an eligible county in order to be eligible to apply. Applicants not located in an eligible county will not be considered for funding.

General grant information

 Most grant programs don't just send you a check



- Some grant programs require you to spend your own money, then you get reimbursed for allowable project expenses
- Most grant programs require some sort of reporting, which may be tied to getting some or all of your funding
- Investigate how you will receive funds before applying!

General grant information

- There may be tax liabilities that result from receiving a grant
- Talk with a TAX CONSULTANT if you have questions!

NCR-SARE Farmer Rancher Grant Program 2017 Call for Proposals Farmer Rancher Sustainable Agriculture Grants

Farmer Rancher Grants are for farmers and ranchers who want to earry out Sustainable Agriculture research, demonstration, and education projects on their furns/ranches. The Farmer Rancher Grant call is released in August and proposals are due in December. A total of approximately \$400,000 is available for this program. Grant recipients have 23 months to complete their projects.

TO SUBMIT A PROPOSAL, go to http://www.ciids.org/nesare/fr

The online submission system will open on August 15, 2016. Proposals are due by 4:00 p.m. CST, Thursday, December 8, 2016. If you are unable to use the online system you may submit a proposal by mail or e-mail. Proposals sent by Fax will NOT be accepted. Mail and e-mail submissions must be received by 4 p.m. CST on Thursday, December 8, 2016. The online application has strict word limits, and we strongly suggest you propare your proposal using a word processing program, edit each response to comply with the word limits, and then copy and paste your proposal section by section into the online template, saving as you go. This call for proposals is available on the North Central SARE web site at www.northcontralsare.org If you need a printed application, call 612-626-3113.


- This non-profit foundation sponsors research, including farmer-directed research related to organic farming practices. Proposals are considered twice a year in May and November. For more information, call 831-426- 6606 or go to www.ofrf.org.
- Local Community Foundations
- Local Philanthrophic Foundations
- Again, they will have certain things they fund
- Their grant programs aren't always widely advertised, **doesn't hurt to call**

• You have found a grant program, but the RFP is closed. What do you do?



- Look at the closing date, many grants are on an annual cycle
- Give yourself a reminder to check 2 3 months before that date next year
- Many funders have sign-ups for email newsletters, updates and notifications
- Sign-up and read their emails!

• You have found a grant program that meets your general information requirements, Now what do you do?



- Thoroughly read the RFP, then read it again!
- Also, read organizations mission, goals and objectives, note key words and concepts, use them
- If you don't understand something call or email the contact, It's their job to help you!
- Writing a grant proposal is a lot of work!
- Don't expend the energy to later realize you won't be considered because you missed something or guessed

 You have found a grant program that meets your general information requirements, Now what do you do?



- Thoroughly read the RFP, then read it again!
- Follow the directions, many RFPs have:
 - Page limits, section limits, font size requirements, margin requirements, description of what goes in a section, etc.
 - These to force you to be concise and not ramble
 - That violating any of these could lead to rejection of the proposal without review
- I hate to tell you, but you are not special, they make the rules!

- Now you are writing...
 - Write clearly and concisely
 - Write logically, don't jump around with you thoughts
 - Build the next thought, sentence, paragraph or section on the previous
 - Don't use acronyms, jargon or technical terms without explaining them
 - Reviewers may not be as well versed in you field as you are
 - Tell them what they need to know, don't assume they already know something



- Now you are writing...
 - Don't make statements you can't backup with data or other references
 - If it is your opinion, say that
 - For example "I believe that..."
 - **Don't use superlatives**, that is a red flag to reviewers
 - "This proposal will produce the very best method to..." What is very best?, Who says?
 - Instead "This proposal will produce a better method to..."
 - Reviewers look for proposals that unbiasedly evaluates something, that are realistic

- Now you are writing...
 - Give them what they ask for, if you can't, explain why, don't ignore
 - You want to convince them to fund your proposal
 - Present realistic, believable and logical reasons why
 - Avoid sales pitches and hyperbole
 - Reviewers have a responsibility to be objective and thorough, they know what to look for



- Now you are **done** writing...
 - Have other people review it
 - Including **someone not familiar** with the topic
 - Address their feedback, if they are confused or don't understand something, reviewers will have the same issues



- Find and fix spelling and grammar mistakes
- **Don't push the deadline**, give yourself time to fix things and re-review what you've written

- Now you are **done** writing...
 - Submit on time!

- Build in time for problems with the submission process
- Most organizations will not accept proposals after the submission deadline
- Most importantly, congratulate yourself for successfully submitting a proposal!

- You've submitted and been rejected...
 - Don't take it personal!
 - They only have so much money, other proposals may have better meet their program objectives
 - Read the reviewer comments
 - If the comments are generally positive, resubmit during the next grant cycle
 - Address negative comments in the next submission
 - **Don't get discouraged**, now you know the process, give it one or two or three... more tries




