## Camping Guidelines for 2019 Washtenaw County 4-H Youth Show



## **RULES FOR CAMPING OVERNIGHT**

1. Exhibitors must have a parent with them at all times for overnight stays and be registered with the Youth Show Office. No dogs are allowed on the grounds or in the campers. (Exceptions are listed on page 9 of the 2019 Washtenaw County 4-H Youth Show Fair Book.)

2. A Camping Registration Information Card must be displayed on the camper at all times. (It is suggested to laminate them or seal them in a page protector to protect them from weather.)

3. Access within the fenced grounds will be closed at 11:00 p.m. each day and opened at 6:00 a.m. each day. No security is provided outside the south fence.

4. No alcoholic beverages or other illegal substances are allowed anywhere on the grounds at any time. This includes within the camper. Any violation of this will result in immediate removal of the camping vehicle from the grounds.

5. No generators within the camping area are permitted.

6. All camping spots will be assigned and confirmation sent via email by July 12.

7. No sharing of electric outlets is allowed. Once assigned, connections may not be moved without the consent of the grounds office.

8. Electric and water services are not guaranteed. The grounds personnel will make every effort to resolve problems promptly but there is no guarantee. No refunds will be given.

## WASHTENAW FARM COUNCIL EMERGENCY ACTION PLAN

1. In the event of an emergency at the Washtenaw Farm Council Grounds, the on-site manager, employee, or Board member will be responsible for declaring the emergency and directing the activities necessary for response. They will also be responsible for declaring the "all clear" once the emergency has been determined to be over.

As all buildings on the Farm Council Grounds have been deemed unsafe in high wind conditions, all attendees on the grounds at the time of a declared emergency are directed to return to their vehicles and remain there until an "all clear" has been announced.
 Do not try to leave the grounds in your vehicle. Remain with your vehicle and await

further instructions.

4. Event staff is to respond to the instructions as directed by the on-site representative of Washtenaw Farm Council as quickly and effectively as possible.

4. All accepted applications will be sent via e-mail information showing the number and location of your slot (an aerial map of the fairgrounds will be provided) and the Camping Registration Card that is to be completed and attached to your unit after arrival.
