

Washtenaw County 4-H Programs - Age Policy \*\*Please Share with Parents\*\*



"4-H age" is determined by a young person's age as of Jan. 1of the current 4-H year (Sept. 1 – Aug. 31).

4-H Cloverbud Members are aged 5, 6, or 7 as of Jan. 1.

A full copy of Michigan "<u>4-H Cloverbud Program Policy Information</u>" is available from 4-H staff. 4-H Cloverbud programs, like all 4-H programming, are designed to be age appropriate, educational and fun. Additionally, 4-H Cloverbud activities have a specific non-competitive focus, and have specific safety requirements when working with animals:

**5-6 year olds** require a parent, guardian, or certified 4-H volunteer to be present and on the ground holding the animals halter/lead (if halter/lead animal) anytime they are working with or near halter/lead animals. They may be involved with a nonhaltered animal as well with direct assistance from a parent, guardian or certified 4-H Volunteer while in contact with the animal.

**7 year olds** require an older 4-H teen or parent, guardian or certified 4-H Volunteer to be present when working with haltered/lead animals as listed above.

In order to participate fully in 4-H and without required direct assistance from an older teen or adult, youth must be 8 to 19 years old as of January 1 of the current 4-H program year (i.e. a member who turns 8 on January 2 would still be a Cloverbud). A member who is 19 on January 1 will be in their last year as a 4-H member in the Washtenaw County 4-H program. For youth over age 8 with individual needs, accommodations can be made for additional assistance from an adult or older teen in any project area. Just let us know at least 2 weeks before any 4-H event.
