There was discussion about changing auction payment procedure if a 4Her wanted to purchase their own animal back. No motion made.

Committee sign up for 2020 – Sign up sheet going around

Club vote to revisit the rule regarding member must show in showmanship, market and at the sale in order to sell market animals.

Lane Sturman made a motion to revisit the topic of the rule that was made at the November meeting. Motion seconded by Jason.

There was much discussion about the issue. Those opposed to the rule felt that the 19 year olds that may be in college were being penalized and wouldn't be able to sell their animals. Those in favor of the rule felt that all three components (market, showmanship, and sale) were vital to completing the project. If buyers are expected to take their time to come support the 4Hers at the auction, the 4Hers should be present as well.

Motion made by Jason to strike all references to the sale from the current rule. Motion seconded by Lane S.

Club vote. Motion Passed 14-7, 1 abstained.

Request to raise fee for Poultry Judges

Don Berens brought up issue that most of his prospective poultry judges are asking for more money than we have spent in the past. We have been paying \$125/judge. Most judges are now asking for \$300

There was discussion about possible capital expenses. There was discussion about looking into purchasing our own gates to use for placing pens for the swine show. Motion made by Jessica Hazen to add \$15,000 to the budget for capital improvements to investigate the cost of pig placing pens or pig fair pens. Seconded by Tina Klingenberg. Motion passed. Verbal vote, none opposed.

Motion by Don Berens to approve budget. Seconded by Jessica H. Motion passed. Verbal vote, none opposed.

Can we have placing ribbons to 5th place?

Currently, the fair provides placing ribbons up to 3rd place. There was discussion that 4Hers should get ribbons to 5th place

Motion made by Jessica H that we ask the fair to provide placing ribbons up to 5th place for showmanship in all species. Seconded by Angie. Motion passed. Verbal vote, none opposed.
