# **Tuscola County 4-H Small Livestock - Rabbits**



- 1. Welcome Glad to see you are exhibiting rabbits this year. We have a large number of rabbits being exhibited in this building. Our cooperation of working together will make this a good learning experience for all of you.
- 2. Check in time for rabbits and cavies will be from 2:00 p.m. to 4:00 p.m. the 1st Sunday of the fair.
- 3. We need to have an adult to supervise this building during the week. We would like to have all parents and leaders to be on duty for a two-hour shift during the week. See me so I can put you on the schedule or see the schedule on the bulletin board. When you are supervising the building; be cautious that there is 1. NO running in the building. 2. NO dogs in the building. 3. NO fingers in the rabbit cages. 4. NO smoking. Lets all help to keep our building neat, clean and safe.
- 4. No cloth ribbons should be put on the cages. Colored stickers that show your placing will be put on your cage card after the show on Monday.
- 5. Meat Pens consist of 3 rabbits. Meat Pens must not be over 70 days of age and each rabbit must weigh from 3 to 5 pounds. Meat Pens must be of the same breed and variety. Each exhibitor is allowed no more than 1 pen of 3 rabbits.
- 6. Members exhibiting Market Rabbits must keep accurate records of their project. The market books must be turned in to the Superintendent on Friday of Fair Week. If I am not available, put them in the trophy case. After the sale Thursday, I will be giving you a Thank You note so you can write a thank you to your buyer. You will not receive your sale money until this report and addressed / stamped Thank You are completed and returned to me.
- 7. All Exhibitors selling animals at the Small Stock Sale will be given a pre-addressed post card to be signed by the buyer, after the animal has been delivered. A copy of the post card is attached. The picture taken at the Small Stock Sale will be your responsibility to deliver to the buyer. You will be notified when the picture can be picked up at the 4-H office.
- 8. Meat Pens will be sold at the Small Stock Sale. Only Meat Pens receiving an "A" placing will be sold. You must be present to sell your animals.
- 9. Judging will begin at 9:00 a.m. on Monday. Showmanship and Meat Pens will be judged first and followed by the Breeds. There will be a lunch break about 12:00 noon.
- 10. EXHIBITORS WILL BE RESPONSIBLE FOR TRANSPORTING THEIR RABBITS TO AND FROM THE JUDGING TABLES. IN CASES WHERE THE 4-HER HAS TWO BREEDS SHOWING AT THE SAME TIME, ANOTHER YOUTH MAY PUT THE ANIMALS ON THE SHOW TABLE.

- 11. If you are the winner of a trophy, your trophy must stay in the showcase during the week. I will give those to you at the end of fair.
- 12. All rabbits must have a legible tattoo in the ear.
- 13. All cavies must have an ear tag
- 14. Rabbits showing signs of illness such as wet noses, including nasal mucus or discharge must be removed from the show and the rabbit barn. Please contact the superintendent immediately when this is discovered.
- 15. Members may exhibit no more than four breeds per exhibitor.
- 16. Each exhibitor must use his/her own rabbit competing in Showmanship.
- 17. All Exhibitors must feed and water their own animals or make arrangements to have them fed if they are not available.
- 18. All rabbit feed emptied from dishes must be disposed of in garbage container, not dumped on the barn floor.
- 19. No water jugs or feed containers are to be left on cages or on the floor below the cages.
- 20. The Overall Showmanship Winner for rabbits and cavies will compete in the Sweepstakes Contest.
- 21. First or second year exhibitors are the only ones who can enter Grade Rabbits.
- 22. Six Class Rabbits can be either a Senior Buck, Senior Doe, Intermediate Buck, Intermediate Doe, Junior Buck or Junior Doe. Four Class Rabbits can be either a Senior Buck, Senior Doe, Junior Buck or Junior Doe. A Six Class and Four Class Breed list is attached.
- 23. All rabbits will be released at 6:00 a.m. on Sunday. All exhibitors are required to participate in clean-up after the animals are released.
- 24. If any questions or problems come up during the week, please contact me immediately.
